#### EUROPEAN COMMUNITIES ACT 1972, FISHERIES ACT 1981 SEA FISHING

The Department of Agriculture, Environment and Rural Affairs has made a Statutory Rule entitled "The Sea Fishing (Illegal, Unreported and Unregulated Fishing) Order (Northern Ireland) 2018 (S.R. 2018 No. 106) which comes into operation on 1 June 2018.

This Statutory Rule implements EC Council Regulation 1005/2008 establishing a Community system to prevent, deter and eliminate illegal, unreported and unregulated (IUU) fishing and Commission Regulation 1010/2009 laying down detailed rules for the implementation of the Council Regulation. The Council and Commission Regulations complement the Fisheries Control Regulation which establishes a modernised system to ensure compliance of European operators with the rules of the European Union (EU) Common Fisheries Policy, and Council Regulation 1006/2008 concerning authorisations for fishing activities of Community fishing vessels outside Community waters and the access of third country vessels to Community waters. These regulations together set up a comprehensive system to ensure the legality of fishing by European vessels and imports of fish and fisheries products into the EU from third countries.
