THE DOUBLE TAXATION RELIEF AND INTERNATIONAL TAX ENFORCEMENT (UZBEKISTAN) ORDER 2018 (SI. 2018 NO. 628) UK/UZBEKISTAN PROTOCOL TO THE DOUBLE TAXATION CONVENTION

The Protocol amending the Convention between the Government of The Republic of Uzbekistan and the Government of The United Kingdom for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income and capital gains, signed on 24 January 2018 in London, entered into force on 1 June 2018. The text of the Protocol to the Double Taxation Convention has been published as the Schedule to the Double Taxation Relief and International Tax Enforcement (Uzbekistan) Order 2018 (Statutory Instrument 2018 No. 628), copies of which can be obtained from The Stationery Office. The text of the Order can also be accessed on the Internet at <http://www.legislation.gov.uk/>. The Protocol to the Convention shall take effect: a) in the United Kingdom: (i) in respect of taxes withheld at source, for amounts paid or credited on or after 1 August 2018 (ii) with respect to income tax and capital gains tax, for any year of assessment beginning on or after 6 April 2019; (iii) with respect to corporation tax, for any financial year beginning on or after 1 April 2019. b) In Uzbekistan: (i) in respect of taxes withheld at source, for amounts paid or credited on or after 1 August 2018; (ii) in respect of other taxes, from 1 January 2019. The provisions of Article 13 (Mutual Agreement Procedure), Article 14 (Exchange of Information) and Article 15 (Assistance in the collection of taxes) shall have effect in both United Kingdom and Uzbekistan from 1 June 2018, without regard to the taxable year or chargeable period to which the matter relates.
