Prince George the Sixth with long and happy Years to reign over us.

And whereas both Houses of the Parliament of Northern Ireland stand adjourned at this present time:

And whereas under an Instrument of Abdication dated the tenth day of December instant His Former Majesty King Edward the Eighth did declare His irrevocable determination to renounce the Throne for Himself and His Descendants and the said Instrument of Abdication has now taken effect, and His Former Majesty's Most Honourable Privy Council and others did meet on Saturday the twelfth day of December, 1936, and did direct that His Royal Highness Prince Albert Frederick Arthur George be proclaimed King by the Style and Title of George the Sixth:

Now, therefore, I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, in His Majesty's name, do hereby summon the Parliament of Northern Ireland to meet on Thursday, the 17th December, 1936, to the intent that such proclamation of His Majesty's accession as may be signed in the Privy Council of Northern Ireland may be read to the Members of both Houses of the said Parliament:

And the Senators and Members of the House of Commons are hereby required to give their attendance accordingly.

Given this twelfth day of December, Nineteen hundred and thirty-six.
