LOCAL GOVERNMENT.
ALTERATION OF BOUNDARIES OF WARDS.

COUNTY BOROUGH OF LONDONDERRY.

WHEREAS by the Londonderry Improvement Act, 1896, the County Borough of Londonderry is divided into five Wards called respectively the East Ward, the North Ward and the South Ward, the Waterside Ward and the West Ward, the boundaries of which are defined in the said Act:

And whereas, by Order dated the 18th day of June, 1925, the Ministry of Home Affairs apportioned the borough councillors and aldermen among the said Wards, and such Order made certain provisions with regard to the election of aldermen and councillors for the said Wards:

And whereas it is enacted by Section 7 of the Local Government Act (Northern Ireland), 1922, as amended by the Local Government Act (Northern Ireland), 1934, that the Ministry of Home Affairs may from time to time make orders dividing a borough, urban district or town into wards and fixing the boundaries of such wards and altering the total number of borough councillors, aldermen, urban district councillors or town commissioners:

Now, therefore, the Ministry of Home Affairs for Northern Ireland, by virtue of the power vested in the Ministry by the Local Government Acts (Northern Ireland), 1898 to 1934, and of all other powers in that behalf enabling it, hereby orders and directs as follows:—

- 1. Notwithstanding anything contained in the Londonderry Improvement Act, 1896, or in any order made by the Ministry of Home Affairs to the contrary, the County Borough of Londonderry shall be divided into three wards to be designated the North Ward, the South Ward and the Waterside Ward, and every Ward shall comprise all the houses, lands, and hereditaments within the limits of the same and the boundaries of such three Wards respectively shall be those described in the First Schedule to this Order.
- 2. There shall be elected on the 15th day of May, 1938, for each of the said three Wards into which the County Borough of Londonderry is by this Order divided the number of aldermen and councillors which is set out in the Second Schedule hereto opposite the names of each of the said Wards.
- The aldermen and councillors of the County Borough of Londonderry in office on the 15th day of May, 1938, shall retire on the 16th day of May, 1938.
- 4. Of the five aldermen and fifteen councillors to be elected on the 15th day of May, 1938, the dates of their several retirements from office shall be as follows:—
 - (a) As regards the councillors in the North Ward and the South Ward two of the six councillors elected on the fifteenth day of May, 1938, shall go out of office on the sixteenth day of May, 1939, two more shall go out of office on the

sixteenth day of May, 1940, and the remaining two shall go out of office on the sixteenth day of May, 1941, and in the Waterside Ward one of the three councillors elected on the fifteenth day of May, 1938, shall go out of office on the sixteenth day of May, 1939, one shall go out of office on the sixteenth day of May, 1940, one shall go out of office on the sixteenth day of May, 1941, and the order of retirement of councillors individually shall be determined by the number of votes received by them respectively on their election in the year 1938, the two councillors in the North Ward and the South Ward having the lowest number of votes retiring in the year 1939, the two councillors in each of the said Wards having the next lowest number of votes retiring in the year 1940, and the two councillors having the highest number of votes remaining in office till the year 1941, and in the Waterside Ward the councillor having the lowest number of votes retiring in the year 1939, the councillor having the next lowest number of votes retiring in the year 1940, and the councillor having the highest number of votes remaining in office till the year 1941, the majority of the whole council always determining, when the votes for any such councillors shall have been equal or when there shall have been no contest, who shall be the councillors to go out of office: Provided always that any councillor so going out of office shall be capable of being forthwith re-elected if duly qualified.

(b) As regards Aldermen in the North Ward and the South Ward, one of the two aldermen elected on the fifteenth day of May, 1938, shall go out of office on the sixteenth day of May, 1941, and the remaining one on the sixteenth day of May, 1944, and the alderman who is to retire in the first instance in each of the said Wards shall be the alderman who was elected in that Ward by the smallest number of votes at the first election, and in the Waterside Ward the alderman elected on the fifteenth day of May, 1938, shall go out of office on the sixteenth day of May, 1944, the majority of the whole Council always determining, when the votes for any such aldermen in the North and South Wards shall have been equal or when there shall have been no contest, who shall be the alderman to go out of office: but any alderman on going out of office may forthwith be re-elected if duly qualified.

The vacancy caused by the going out of

a Ward in manner as aforesaid, shall be filled by the election of an alderman or councillor, who shall not remain in office more than six years or three years, respectively, without being reelected.

FIRST SCHEDULE. NAMES AND BOUNDARIES OF WARDS.

1.—NORTH WARD.

The portion of the County Borough of Londonderry which is included within a line drawn from a point in the boundary of the County Borough in the centre of Creggan Burn where the footpath or right-of-way leading from Rosemount Avenue to Glen Road crosses the said Burn, thence in a south-easterly, south-westerly and southeasterly direction along the boundary between the Parliamentary Division of Foyle and the Parliamentary Division of the City of Londonderry to a point in the centre of the River Foyle opposite the centre of Lower Bennett Street, thence in a north-easterly and northerly direction along the centre of the River Foyle to the point where the County Borough Boundary crosses the said River Foyle, thence in a north-westerly, south-westerly and southdirection along the County Boundary to the point first easterly Borough described.

2.—South Ward.

The portion of the County Borough of Londonderry which is included within a line drawn from a point in the boundary of the County Borough in the centre of Creggan Burn where the footpath or right-of-way leading from Rosemount Avenue to Glen Road crosses the said Burn, thence along the boundary of the County Borough in a south-westerly, south-easterly and easterly direction to a point in the centre of the River Foyle where it is crossed by the County Borough boundary, thence in an easterly direction along the centre of the said River Foyle to a point opposite the centre of Lower Bennett Street, thence in a north-westerly, north-easterly and north-westerly direction along the boundary of the North Ward to the point first described.

3.—WATERSIDE WARD.

From a point in the centre of the River Foyle where it is crossed by the County Borough Boundary near Pennyburn, southeastwards, southwards and westwards along the said County Borough Boundary to the said River Foyle where it is crossed by the said County Borough Boundary in the said River Foyle where it is crossed by the said County Borough Boundary near office of any alderman or councillor of | Foyle Hill, thence north-eastwards and

PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, 1925.

PUBLIC HEALTH (IMPORTED FOOD) AMENDMENT REGULATIONS (NORTHERN IRELAND), 1933.

The Ministry of Home Affairs for Northern Ireland gives notice, in pursuance of the above-named Regulations, that it hereby recognises for the purposes of items (a) and (c) of the Second Schedule to the Amendment Regulations, i.e.:—

- (a) A severed part of the carcase of an animal (including the head or any part thereof, and the whole carcase without the head, but not including any part of the carcase of a pig which has been salted, cured, pickled, dried or smoked, or otherwise prepared in the manner in which bacon or ham is ordinarily prepared), from which no submaxillary, pre-scapular, pre-crural, superficial inguinal, supramammary, or popliteal gland has been taken out;
- (c) All edible parts of an animal other than (i) the head or other severed parts of the carcase, (ii) the intestines prepared in the form of sausage casings, and (iii) meat which has before importation been made ready for human consumption in the form of a sausage or other prepared or manufactured article of food;

each of the Official Certificates of which particulars are given in the Schedule hereto, as evidence that the meat to which it relates has been derived from an animal which was free from disease at the time of slaughter, and has been dressed or prepared and packed with all necessary precautions for the prevention of danger to public health.

Where the Certificate is in the form of a label the recognition will apply only if the label is securely affixed to the package containing the meat, and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp the recognition will apply only if the stamp is clearly impressed on the meat.

The label and stamp hereby recognised as Official Certificates for meat imported from the Union of South Africa are in substitution for the label of which particulars were

given in Part VIII of the First Schedule to the Notice published in the London Gazette of the 14th July, 1933, (and referred to in the Notice published in the Belfast Gazette of the 4th August, 1933).

The label hereby recognised as an Official Certificate for meat imported from the Commonwealth of Australia is in addition to the labels of which particulars were given in Part III of the First Schedule to the Notice published in the London Gazette of the 14th July, 1933 (and referred to in the Notice published in the Belfast Gazette of the 4th August, 1933), and in Part 1 of the First Schedule to the Notice published in the London Gazette of the 1st December, 1933 (and referred to in the Notice published in the Belfast Gazette of the 15th December, 1933).



IMPORT DUTIES ACT, 1932, AND FINANCE ACT, 1933.

WHEREAS it is provided by sub-section (1) of Section 9 of the Import Duties Act, 1932 (22 Geo. 5, ch. 8), that, with a view to obtaining information as to the condition and progress of trades and industries engaged in the manufacture in the United Kingdom of goods of a class or description which, if they were imported into the United Kingdom, would be chargeable with a duty of customs under Part 1 of that Act, the Board of Trade may, before the commencement of the year nineteen hundred and thirty-three and any subsequent year, publish in the Gazette Notice that they will require returns in relation to that year in accordance with the provisions of the said section:—

And whereas it is provided by sub-section (7) of Section 9 and by sub-section (2) of Section 20 of the Finance Act, 1933, that Section 9 of the Import Duties Act, 1932, shall have effect as if references to a duty of customs chargeable under Part 1 of that Act included references to a duty of customs chargeable under Section 9 of the Finance Act, 1933, a duty of customs chargeable under

Section 3 of the Finance Act, 1925, and a duty of customs chargeable under the Safeguarding of Industries Act, 1921.

Now, therefore, the Board of Trade in exercise of the powers conferred on them by Section 9 of the Import Duties Act, 1932, as extended by Sections 9 and 20 of the Finance Act, 1933, hereby give notice that they will require returns in relation to the year 1937, to be delivered to them in accordance with the provisions of the first abovementioned Section in respect of the manufacture in the United Kingdom of goods of any class or description which, if they were imported into the United Kingdom, would be chargeable with a duty of customs under any of the enactments following, namely:—
