THE SOCIAL SECURITY CONTRIBUTIONS AND BENEFITS (NORTHERN IRELAND) ACT 1992, THE JOBSEEKERS (NORTHERN IRELAND) ORDER 1995, THE STATE PENSION CREDIT ACT (NORTHERN IRELAND) 2002, THE WELFARE REFORM ACT (NORTHERN IRELAND) 2007 THE SOCIAL FUND AND INCOME-RELATED BENEFITS (MISCELLANEOUS AMENDMENTS AND SAVINGS) REGULATIONS (NORTHERN IRELAND) 2018

The Department for Communities has made a Statutory Rule entitled "the Social Fund and Income-Related Benefits (Miscellaneous Amendments and Savings) Regulations (Northern Ireland) 2018", (S.R. 2018 No. 192), which comes into operation immediately after the coming into force of the first Regulations made under section 32 of the Social Security (Scotland) Act 2018.

This Rule will make minor technical amendments to ensure that only claimants living in Northern Ireland are eligible for a Sure Start Maternity Grant. It will also ensure recipients of the pregnancy and baby element of the Early Years Assistance (Best Start Grants) who subsequently move from Scotland to Northern Ireland are not eligible for the Sure Start Maternity Grant. In addition the Rule will ensure that Early Years Assistance (Best Start Grants) is disregarded for income and capital purposes in the same way as the current Sure Start Maternity Grant is in income-related benefits.
