### THE WASTE REGULATIONS (NORTHERN IRELAND) 2019

The Department of Agriculture, Environment and Rural Affairs has made a Statutory Rule entitled The Waste Regulations (Northern Ireland) 2019 (SR No 240) which comes into operation on 16th January 2020

The amendments made by these regulations substitute references to the Waste Management Strategy with references to the Waste Management Plan. This more accurately reflects the wording of the Waste Framework Directive. Northern Ireland's existing Waste Management Strategy 2013 and Council Waste Management Plans meet the requirements for a Waste Management Plan. In December 2019 the Department of Agriculture, Environment and Rural Affairs published a Waste Management Plan rather than a replacement strategy. The amendments made by these regulations are consistent with this approach.

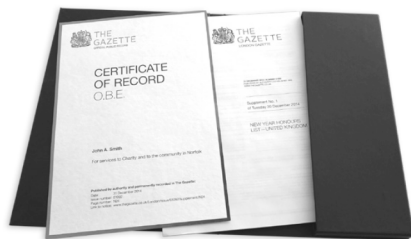

13 The Advertiser agrees to fully indemnify (as a debt) and hold the Publisher and The National Archives or any successor organisation, including any affiliates, officers, directors, agents, subcontractors and employees harmless from all liabilities , costs, expenses, damages and losses (including, without limitation) any direct, indirect, consequential and/or special losses and/or damage, loss of profit, loss of reputation and/or goodwill and all interest, penalties and legal costs (calculated on a full indemnity basis) and all other professional costs and/or expenses (including legal costs) suffered or incurred (including negligence) in respect of any matter arising out of, in connection with or relating to any Notice (including, without limitation , clause 11 of the Terms and Conditions) and including (without limitation) in respect of any claim and/or demand (including threatened and/or potential claims or demands) made by any third party which may constitute a breach and/or potential breach by the Advertiser (or their principal) of these Terms and Conditions or of any law and/or any of the rights of a third party.
