County Court Judges' (Salaries), Expiring Laws Continuance, Finance (No. 2), Exchequer and Financial Provisions, Labourers' Cottages (Loans), Poor Relief (Amendment), Marketing of Eggs, Milk and Milk Products, Widows', Orphans' and Old Age Contributory Pensions (Voluntary Contributors), Finance, Huddleston's Divorce, Love's Divorce, McMeekin's Divorce.

SHOPS ACT, 1912.

BY THE GOVERNOR OF NORTHERN IRELAND.

ABERCORN.

WHEREAS it is enacted by sub-section one of Section 6 of the Shops Act, 1912, that whenever a local authority are satisfied that a prima facie case is made out for making a Closing Order, the authority shall give

in the prescribed form of their intention to make an order specifying therein a period (not being less than the prescribed period) within which objections may be made to the making of the proposed order and that if after taking into consideration any objections they may have received the local authority are satisfied that it is expedient to make the order and that the occupiers of at least two-thirds in number of the shops to be affected by the order approve the order they may make the order:

And Whereas it is enacted in effect by sub-section two of Section 6 of the said Act that notice of the provisions of the order shall be given and copies thereof shall be supplied in the prescribed manner and the order shall be submitted to the Governor of Northern Ireland and the Governor of Northern Ireland shall consider any objections to the order and may either disallow the order or confirm the order with or without amendment:

And Whereas the Urban District Council of Dungannon, after complying with the provisions of the said sub-section one of Section 6 of the said Act and the regulations made thereunder, have submitted to me a Closing Order made on the 28th June, 1937, fixing the hours on the several days of the week at which certain shops in the said Urban District shall be closed for the serving of customers:

Ten o'clock p.m. shall be substituted for nine o'clock p.m. in the said Order as the closing hour on Saturdays for the shops therein mentioned.

MARKETING OF EGGS. DETERMINATION OF WHOLESALE DEALERS' PRICES.

ORDER DATED THE FIFTH DAY OF NOVEMBER, 1937, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION ONE OF THE MARKETING OF EGGS ACT (NORTHERN IRELAND), 1936.

The Ministry of Agriculture, in exercise of the powers conferred on it by section one of the Marketing of Eggs Act (Northern Ireland), 1936, and of every other power enabling it in that behalf, and in accordance with advice given by the Egg Marketing Committee for Northern Ireland hereby determines as follows, that is to say:—

1. The prices payable by licensed wholesale dealers for eggs delivered during the week ending Saturday, the 6th November, 1937, shall be as follows:—

HEN EGGS.

- (a) (i) For hen eggs purchased by a licensed wholesale dealer from a producer where the eggs were produced by the producer's own hens, 1/2\frac{3}{4}d. per lb.:

 Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, an additional
 - (ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 1/3 3-16d, per lb.;

halfpenny per lb. shall be paid;

Provided that where the licensed wholesale dealer of Class B had accepted delivery of the eggs during the week ended 30th October, 1937, the price payable to him for such eggs by a licensed wholesale dealer of Class A shall be 1/1 15-16d, per lb.

Duck Eggs.

(b) For duck eggs purchased by a licensed wholesale dealer from a producer where the eggs were produced by the producer's own ducks, 1/5½d. per dozen:

Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, an additional three-farthings shall be paid for each complete dozen so delivered.

2. This Order may be cited as the Marketing of Eggs (Determination of Wholesale Dealers' Prices) (No. 5) Order (Northern Ireland), 1937, and shall be construed as one with the Marketing of Eggs (Determination of Wholesale Dealers' Prices) Order (Northern Ireland), 1937.
