The Civil Service Commissioners for Northern Ireland hereby give notice that the following Regulations are published with the approval of the Ministry of Finance for Northern Ireland, viz.:—

REGULATIONS RESPECTING AN OPEN COMPETITION FOR THE SITUATION OF CLERICAL ASSISTANT, GRADE II. (FEMALE) IN THE CIVIL SERVICE.

- 1. The limits of age are 18 and 20. A candidate must have attained the lower age and must not have attained the higher age on or before the governing date. The governing date is the 31st March where the competition commences in the first six months of the year, and the 30th September where it commences in the second six months of the year.
- Every candidate must be a naturalborn British subject, the child of a person who is or was at the time of death a British subject; provided that if the Civil Service Commissioners are satisfied in the case of any candidate who is a British subject but does not fulfil all the requirements of the rule as to nationality and descent, that the candidate is so closely connected by ancestry upbringing with His Majesty's Dominions that an exception may properly be made to that rule, they may accept such candidate as eligible provided that this discretion shall not be exercisable unless (a)

the father or the paternal grandfather of the candidate was a natural-born British subject, and (b) neither the father nor the paternal grandfather had acquired any other nationality by naturalization or by any other voluntary and formal act.

- 3. A candidate must be unmarried or a widow.
- 4. A person upon whose training for the occupation of teacher public money has been spent, cannot, if successful, be appointed until the consent of the Ministry of Finance has been notified to the Civil Service Commissioners.
- 5. The competition will consist of two parts, and the subjects of examination will be as follows:—
