A PROCLAMATION

FOR APPOINTING TUESDAY, JULY 12th, 1938, A BANK HOLIDAY AND A PUBLIC HOLIDAY IN NORTHERN IRELAND.

I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland in pursuance of the Bank Holidays Act, 1871, the Holidays Extension Act, 1875, and the Irish Free State (Consequential Provisions) Act, 1922, and of every power me thereunto enabling, do hereby appoint Tuesday, the Twelfth day of July next, as a special day to be observed as a Bank Holiday and as a Public Holiday in Northern Ireland, under and in accordance with the said Acts, and I do by this Proclamation command the said day to be so observed, and all loving subjects of His Majesty to order themselves accordingly.

Given at Government House, Hillsborough, this thirtieth day of March, in the year of Our Lord one thousand nine hundred and thirty-eight.

THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

THE LOCAL GOVERNMENT ACTS (NORTHERN IRELAND), 1898 to 1937. URBAN DISTRICT OF NEWCASTLE.

To the Council of the Urban District of Newcastle; and to all others whom it may concern:

Whereas by the Local Government Act (Northern Ireland), 1922 (hereinafter referred to as "the Act"), it is provided that on and after the ordinary day of election in the year Nineteen Hundred and Twenty-three, the members of the Council of an urban district in Northern Ireland shall be elected for wards or urban districts instead of for the local electoral areas formed under the Local Government (Ireland) Act, 1919:

And whereas by Section 7 of the Act it is provided that the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") may make an Order dividing an urban district into wards, and fixing the boundaries of such wards, altering the number

and boundaries of the wards or altering boundaries of the wards without altering their number and apportioning the urban district councillors among the wards, and that the Ministry may make such orders, as appear to it to be necessary or proper for giving full effect to the Act, and that before making an order for any of the aforesaid purposes the Ministry shall consult with the Council of the urban district, and may, if the Ministry deems it necessary, hold a local inquiry into the matter of any representations made by any such Council.

And whereas it is enacted by sub-section 5 of section 24 of the Local Government Act (Northern Ireland) 1934, that the power conferred upon the Ministry by section 7 of the Act to make orders shall include the power to make orders as respects a borough urban district or town for altering the total number of borough councillors, aldermen, urban district councillors or town commissioners.

And whereas the Urban District of Newcastle was by order dated the 6th November, 1922, divided into two Wards called respectively the North Ward and the South Ward,

and six members assigned to each of the said Wards.

And whereas the Ministry considers it expedient that the said order dated the 6th November, 1922, should be revoked and that the members of the Urban District Council of Newcastle should be elected for the urban district and that the total number of urban councillors should be altered from twelve to nine.

Now, therefore, the Ministry of Home Affairs for Northern Ireland, in exercise of the powers vested in it by the Local Government Acts (Northern Ireland), 1898 to 1937, and of all other powers in that behalf enabling the Ministry hereby orders and directs as follows:—

- 1. The Order made by the Ministry on the 6th day of November, 1922, dividing the Urban District of Newcastle into Wards and apportioning the Urban District Councillors among the said Wards, shall be revoked.
- 2. All the members of the Council of the Urban District of Newcastle in office on the 15th day of May, 1939, shall retire on the 6th day of May, 1939.
- 3. On the 15th day of May, 1939, there shall be elected Nine Councillors for the area comprising the Urban District of Newcastle.

MARKETING OF EGGS.

DETERMINATION OF WHOLESALE DEALERS' PRICES.

ORDER DATED THE FIRST DAY OF APRIL, 1938, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION ONE OF THE MARKETING OF EGGS ACT (NORTHERN IRELAND), 1936.

The Ministry of Agriculture, in exercise of the powers conferred on it by section one of the Marketing of Eggs Act (Northern Ireland), 1936, and of every other power enabling it in that behalf and in accordance with advice given by the Egg Marketing Committee for Northern Ireland hereby determines as follows, that is to say:—

1. Subject as hereinafter provided, the prices payable by licensed wholesale dealers for eggs delivered during the week ending Saturday, 2nd April, 1938, shall be as follows:—

HEN EGGS.

(a) (i) For hen eggs purchased by a licensed wholesale dealer from a producer where the eggs were pro-

duced by the producer's own hens, 51d per lb.:

Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, or to the premises set forth in the Schedule to this Order, an additional halfpenny per lb. shall be paid;

(ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 5 11-16d. per lb.:

DUCK EGGS.

- (b) For duck eggs purchased by a licensed wholesale dealer from a producer where the eggs were produced by the producer's own ducks 8d. per dozen:

 Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading
 - delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, or to the premises set forth in the Schedule to this Order, an additional three-farthings shall be paid for each complete dozen so delivered.
- 2. Deductions shall be made from the foregoing prices at the following rates in respect of eggs of the descriptions specified:

For each hen egg marked "Second" ½d.;

For each hen egg marked "Reject" 3d.;

For each duck egg marked . "Reject" \darkqd.:

3. This Order may be cited as the Marketing of Eggs (Determination of Wholesale Dealers' Prices (No. 13) Order (Northern Ireland), 1938, and shall be construed as one with the Marketing of Eggs (Determination of Wholesale Dealers' Prices) Order (Northern Ireland), 1937.

PUBLIC HEALTH (IMPORTED FOOD)
REGULATIONS (NORTHERN
IRELAND), 1937.

The Ministry of Home Affairs hereby gives notice, in pursuance of the abovenamed Regulations, that it will recognise from the date of operation of the Regulations each of the Official Certificates of which particulars are given in the Schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post-mortem and passed in accordance with criteria satisfactory to the Ministry; and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or to the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat or the container, as the case may be.

The Public Health (Imported Food) Regulations (Northern Ireland), 1925, and the Public Health (Imported Food) Amendment Regulations (Northern Ireland), 1933, are revoked from the date of operation of the Public Health (Imported Food) Regulations, Northern Ireland, 1937, and all notices published in the Belfast Gazette relating to the recognition of Official Certificates for the purposes of the revoked Regulations will cease to have effect on that date.





TRADE BOARDS ACT (NORTHERN IRELAND), 1923.

BOOT & SHOE REPAIRING TRADE BOARD

(NORTHERN IRELAND).

The Trade Board established by the Ministry of Labour for Northern Ireland under powers conferred by the Trade Boards Act (Northern Ireland), 1923, for the Boot and Shoe Repairing Trade in Northern Ireland as defined in the Schedule to the Trade Boards (Boot and Shoe Repairing Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1925, dated 30th July, 1925, hereby give notice that they propose to vary the general minimum time-rates, piece-work basis time-rates, general minimum piece-rates and general overtime rates for certain male and female workers in the trade.

On request to the Trade Board particulars of the proposed variation of minimum rates will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposals which may be lodged with them within fourteen days from the sixth day of April, 1938. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary of the Boot

and Shoe Repairing Trade Board (Northern Ireland), Office of Trade Boards, Stormont, Belfast. It is desirable that persons making objections should state, as far as possible, the precise grounds therefor.
