CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 and 1933.

Whereas there is reason to believe that assemblies of persons have been or are about to be convened for the purpose of holding meetings or processions in Northern Ireland to commemorate the Rebellion of Easter Week, 1916, or for the promotion of the objects of the Irish Republican Army or any other unlawful Association:

And whereas there is reason to apprehend that such assemblies of persons and the holding of such meetings or processions will give rise to grave disorder or conduce to a breach of the peace or promote disaffection and thereby cause undue demands to be made upon the Police Force:

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Bart., Minister of Home Affairs for Northern Ireland, being the Civil Authority under the said Acts, do hereby in accordance with the provisions of Regulation 4 of the Regulations made under the authority of the above-mentioned Acts prohibit the holding of any such assemblies, meetings, or processions in Northern Ireland during the period from the 13th day of April, 1938, to the 20th day of April, 1938, both dates inclusive.

MARKETING OF EGGS.

DETERMINATION OF WHOLESALE DEALERS' PRICES.

ORDER DATED THE EIGHTH DAY OF APRIL, 1938, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION ONE OF THE MARKETING OF EGGS ACT (NORTHERN IRELAND), 1936.

The Ministry of Agriculture, in exercise of the powers conferred on it by section one of the Marketing of Eggs Act (Northern Ireland), 1936, and of every other power enabling it in that behalf and in accordance with advice given by the Egg Marketing Committee for Northern Ireland hereby determines as follows, that is to say:—

1. Subject as hereinafter provided, the prices payable by licensed wholesale dealers for eggs delivered during the week ending Saturday, 9th April, 1938, shall be as follows:—

HEN EGGS.

(a) (i) For hen eggs purchased by a licensed wholesale dealer from a producer where the eggs were produced by the producer's own hens, 5½d. per lb.:

Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, or to the premises set forth in the Schedule

to this Order, an additional halfpenny per lb. shall be paid;

(ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 5 15-16d. per lb.:

Provided that where the licensed wholesale dealer of Class B had accepted delivery of the eggs from a producer during the week ended 2nd April, 1938, the price payable to him for such eggs by a licensed wholesale dealer of Class A shall be 5 11-16d. per lb.:

DUCK EGGS.

(b) For duck eggs purchased by a licensed wholesale dealer from a producer where the eggs were produced by the producer's own ducks 7½d. per dozen:

Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, or to the premises set forth in the Schedule to this Order, an additional three-farthings shall be paid for each complete dozen so delivered.

2. Deductions shall be made from the foregoing prices at the following rates in respect of eggs of the descriptions specified:

For each hen egg marked "Second" ½d.;

For each hen egg marked "Reject" 3d.;

For each duck egg marked "Reject" \(\frac{2}{3} \)d.:

3. This Order may be cited as the Marketing of Eggs (Determination of Wholesale Dealers' Prices (No. 14) Order (Northern Ireland), 1938, and shall be construed as one with the Marketing of Eggs (Determination of Wholesale Dealers' Prices) Order (Northern Ireland), 1937.

PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, (NORTHERN IRELAND), 1937.

The Ministry of Home Affairs hereby gives notice, in pursuance of the abovenamed Regulations, that it will recognise from the date of operation of the Regulations each of the Official Certificates of which particulars are given in the Schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared, was derived from inspected ante- and post-mortem and passed in accordance with criteria satisfactory to the Ministry, and (b) that all necessary pre-cautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or to the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate, and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat or the container, as the case may be.

The Public Health (Imported Food) Regulations (Northern Ireland), 1925, and the Public Health (Imported Food) Amendment Regulations (Northern Ireland), 1933, are revoked from the date of operation of the Public Health (Imported Food) Regulations (Northern Ireland), 1937, and all notices published in the Belfast Gazette relating to the recognition of Official Certificates for the purposes of the revoked Regulations will cease to have effect on that date.

MERCHANDISE MARKS ACT, 1926.

REFERENCE TO THE STANDING COMMITTEE.

In accordance with the provisions of subsection (4) of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin they have made a reference to the Standing Committee appointed by them under the Act in respect of the following descriptions of imported goods:—

Straps, wristlets, bands, cordettes and similar articles ordinarily worn with watches, but not including those made wholly or mainly of metal.
