Whereas by Sub-section 1 of Section 11 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, it is provided that the Ministry of Home Affairs may from time to time by Order declare that from such date as may be specified in that behalf in the Order, two or more Petty Sessions districts, whether they are all situate in the same County or not, shall be served by one and the same person as Petty Sessions Clerk:

And whereas it appears to the Ministry to be desirable that each of the Petty Sessions districts of:—

- (a) Castlederg, Newtownstewart, and Strabane, in County Tyrone;
- (b) Donemanagh and Gortin, in County Tyrone;

shall respectively be served by one and the same person as Petty Sessions Clerk:

Now, therefore, the Ministry of Home Affairs for Northern Ireland, in pursuance of the powers vested in it by Section 11 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, hereby orders as follows:—

From and after the first day of December, 1938, the Petty Sessions districts of:—

- (a) Castlederg, Newtownstewart, and Strabane, in County Tyrone;
- (b) Donemanagh and Gortin in County
 Tyrone;

shall respectively be served by one and the same person as Petty Sessions Clerk.

This Order may be cited as the Summary Jurisdiction (Petty Sessions districts) (No. 7) Order (Northern Ireland), 1938.

SUMMARY JURISDICTION.

Whereas it is enacted in effect by Sub-section 2 of Section 11 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, that where an Order is in force directing that two or more Petty Sessions districts are to be served by one and the same person as Petty Sessions Clerk and the Ministry of Home Affairs is of opinion that such service is inconvenient the Ministry may make an Order rescinding the first mentioned Order:

PETTY SESSIONS DISTRICTS AND TIMES.

SUPREME COURT OF JUDICATURE OF NORTHERN IRELAND.

MARKETING OF EGGS (DETERMINA-TION OF WHOLESALE DEALERS' PRICES) (No. 45) ORDER (NORTHERN IRELAND), 1938.

the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional halfpenny per lb. shall be paid.

(ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 1/3 11-16d. per lb. Deductions:—Seconds ½d per egg;

Rejects 2d. per egg.

(b) For duck eggs purchased from a producer 1/5d, per dozen.
Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional three-farthings shall be paid for each complete dozen so delivered.
