STAMP DUTIES.

Whereas Section 12 (2) of the Finance Act, 1899, provides inter alia that His Majesty's Commissioners of Inland Revenue may substitute, as respects any foreign or colonial currency mentioned in the Schedule to that any rate of exchange for specified in the Schedule and may add to the Schedule a rate of exchange for any foreign or colonial currency not mentioned therein, and that such Act shall be construed as if any rate of exchange for the time being substituted or added were contained in the said Schedule, and in the case of the substitution of a rate of exchange as if the rate for which the new rate is substituted were omitted from that Schedule. MARKETING OF EGGS (DETERMINA-TION OF WHOLESALE DEALERS' PRICES (No. 20) ORDER (NORTHERN IRELAND), 1939.
