MARKETING OF EGGS (DETERMINATION OF WHOLESALE DEALERS' PRICES) (No. 27) ORDER (NORTHERN IRELAND), 1939.

- (ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 9 3-16d. per lb.  
Deductions:—Seconds ¼d per egg;  
Rejects 1¼d. per egg.  
(b) For duck eggs purchased from a producer 10d. per dozen.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional three-farthings shall be paid for each complete dozen so delivered.
