ROPE, TWINE AND NET TRADE BOARD.
(NORTHERN IRELAND).

The Trade Board established in Northern Ireland under the powers vested in the Ministry of Labour for Northern Ireland, and in pursuance of Section 8 of the Government of Ireland Act, 1920, and the enactments modified and adapted by the Government of Ireland (Adaptation of Enactments) (No. 3) Order, 1921, and any other Order of His Majesty in Council made under the said Act of 1920, for those branches of the Rope, Twine and Net Trade specified in the Regulations of the said Ministry, dated Second day of January, 1922, having, as required by Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, dated 31st October, 1918, given due notice on the 27th day of January, 1923, of Proposal to vary minimum rates of wages for certain classes of Female Workers.

The Trade Board have further given notice that they have received notification that an Order was made by the Minister of Labour for Northern Ireland on the Tenth day of April, 1923, confirming the said minimum rates as varied by the Trade Board, as aforesaid, and specifying the Sixteenth day of April, 1923, as the date from which said variations should become effective.

On request to the Trade Board particulars of the minimum rates and information as to their application will be given, if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

# THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND.

URBAN DISTRICT OF NEWCASTLE.

To the Council of the Urban District of Newcastle; and to all others whom it may concern:

WHEREAS the Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by Section 3 of the Local Government Act (Northern Ireland), 1922 (hereinafter referred to as "the Act"), did by an Order bearing date the 9th day of November, 1922, on request made by a resolution of the Council of the Urban District of Newcastle, passed by a majority of the members voting on such resolution, apply to the said Urban District in lieu of the provisions relating to triennial elections which are contained in the Local Government (Ireland) Act, 1919 (hereinafter referred to as "the Act"), as amended by the Act, the enactments which were in force immediately before the commencement of the said Local Government (Ireland) Act, 1919, with respect to the election and retirement of Urban District Councillors, and did make certain incidental provisions which appeared to the Ministry to be necessary:

And whereas the said Council of the Urban District of Newcastle by a resolution passed by a majority of the members of the Council revoked the hereinbefore mentioned resolution, and has applied to the Ministry of Home Affairs to revoke the aforesaid Order, bearing date the 9th day of November, 1922:

Now therefore the Ministry of Home Affairs for Northern Ireland in exercise of the powers vested in it by the Act, and of all other powers in this behalf enabling the Ministry, hereby revokes its Order bearing date the 9th day of November, 1922, and by this Order directs that the Urban District Councillors at present representing each of the wards of the Urban District of Newcastle shall remain in office until the day on which they would have retired as if the said Order of the 9th day of November, 1922, had not been made.

### ADMINISTRATIVE COUNTY OF TYRONE

To the Council of the Administrative County of Tyrone; to the Council of the Rural District of Castlederg; and to all whom it may concern:

WHEREAS under sub-section (2) of section 27 of the Local Government (Ireland) Act, 1898, and the Certificate of the Local Government Board for Ireland; bearing date the 6th day of July, 1899, made thereunder, the limit of annual expenditure on roads in the Rural District of Castlederg which may be approved of without the consent of the Ministry of Home Affairs for Northern Ireland, by the Council of the Administrative County of Tyrone (hereinafter referred to as the County Council), is £3,577 108 0d:

And whereas by an Order under Seal bearing date the 29th day of November, 1922, the Ministry of Home Affairs for Northern Ireland did approve of the sum of £6,127 10s 0d as the limit of expenditure on the roads of the said Rural District which the County Council might approve for the local financial year ending on the 31st day of March, 1924.

And whereas the said Ministry is satisfied that the expenditure on the roads of the said Rural District for the local financial year ending on the Thirty-first day of March, 1924, of the said sum of £6,127 10s 0d will not admit of the said roads being kept in proper condition and repair:

Now therefore, the Ministry of Home Affairs for Northern Ireland in exercise of all powers in that behalf enabling the Ministry, by this Order consents and declares that the County Council may, if they see fit, approve of the expenditure on the roads of the Rural District of Castlederg, proposed or about to be proposed by the Council of the said Rural District for the local financial year ending on the Thirty-first day of March, 1924, provided always that this consent and declaration shall not extend to the approval by the County Council of any expenditure proposed or about to be proposed as aforesaid, which is not in accordance with the report and recommendations of the County Surveyor, or which will cause the total expenditure on the roads of the said Rural District in the said local financial year to exceed the sum of Seven thousand four hundred pounds.
