## A PROCLAMATION

Appointing Monday, the fourth day of September, one thousand nine hundred and thirty-nine, a Bank Holiday throughout the United Kingdom for the purposes of the Bank Holidays Act, 1871.

GEORGE R.I.

Whereas We consider it desirable, by reason of the present emergency, that Monday, the fourth day of September, one thousand nine hundred and thirty-nine, should be kept as a close holiday in all banks within the United Kingdom, and should, as regards bills of exchange and promissory notes payable in the United Kingdom, be deemed to be a Bank Holiday for all the purposes of the Bank Holidays Act, 1871:

Now, therefore, in exercise of the powers conferred by section four of the said Act, We do by this Our Royal Proclamation, by and with the advice of Our Privy Council, appoint the said fourth day of September to be observed as a Bank Holiday throughout the United Kingdom.

And We do declare that this Proclamation does not have the effect of making the said day a holiday under, or for the purposes of, the Holidays Extension Act, 1875, or the Revenue Offices (Scotland) Act, 1880.

Given at Our Court at Buckingham Palace, this third day of September, in the year of our Lord, one thousand nine hundred and thirty-nine, and in the Third year of Our Reign.

## MARKETING OF EGGS (DETERMINATION OF WHOLESALE DEALERS' PRICES) (No. 36) ORDER (NORTHERN IRELAND), 1939.

Notice is hereby given that an Order has been made by the Ministry of Agriculture determining that the prices payable by licensed wholesale dealers for eggs delivered during the week ended Saturday, 9th September, 1939, shall be as follows.—

(a) (i) For hen eggs purchased from a producer 1/- per lb.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional halfpenny per lb. shall be paid.

(ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 1/0 7-16d. per lb.

Deductions:—Seconds ½d. per egg; Rejects 1½d. per egg.

(b) For duck eggs purchased from a producer 1/3d. per dozen.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an

additional three-farthings shall be paid for each complete dozen so delivered.

Deductions:—Rejects 1½d. per egg.

#### SUMMARY JURISDICTION.

Whereas by Sub-section 1 of Section 11 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, it is provided that the Ministry of Home Affairs may from time to time by Order declare that from such date as may be specified in that behalf in the Order, two or more Petty Sessions districts, whether they are all situate in the same County or not, shall be served by one and the same person as Petty Sessions Clerk:

And whereas it appears to the Ministry to be desirable that the Petty Sessions districts of Banbridge, Gilford and Rathfriland, County Down, shall be served by one and the same person as Petty Sessions Clerk:

Now, therefore, the Ministry of Home Affairs for Northern Ireland in pursuance of the powers vested in it by Section 11 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, hereby orders as follows:—

From and after the 5th day of January, 1940, the Petty Sessions Districts of Banbridge, Gilford and Rathfriland, County Down, shall be served by one and the same person as Petty Sessions Clerk.

This Order may be cited as the Summary Jurisdiction (Petty Sessions districts) (No. 1) Order (Northern Ireland), 1939.

#### OPEN GENERAL EXPORT LICENCE. No. G.L. 208. TOBACCO.

Whereas by the Export of Goods (Prohibition) (No. 2) Order, 1939, the exportation of certain goods including the goods hereinafter mentioned was prohibited unless the exportation of the said goods is authorised by a licence of the Board of Trade.

Now, therefore, the Board of Trade do hereby authorise and permit the exportation of tobacco from any port in the United

Kingdom subject to the following conditions:—

- (1) That the owner or shipper of the said goods, if so required by the Commissioners of His Majesty's Customs and Excise, shall produce to them, within such time as they may allow, proof to their satisfaction that the said goods were duly delivered to the destination stated in the shipping documents;
- (2) This licence may be modified or revoked at any time by the Board of Trade, without reason given.

This licence shall come into force on the 11th September, 1939.
