CUSTOMS EXPORT LICENCE CERTAIN FOODSTUFFS.

Open General Export Licence, Dated September 16th, 1939, made by the Board of Trade.

Whereas by the Export of Goods (Prohibition) (No. 2) Order, 1939, (a) the exportation of certain goods, including, inter alia, the goods included in the first and second schedules hereto, was prohibited unless the exportation of the said goods is authorised by a licence of the Board of Trade.

Now therefore the Board of Trade under and for the purposes of the said Export of Goods (Prohibition) (No. 2) Order, 1939, do hereby authorise and permit the export of any of the goods specified in the first Schedule hereto from any port in the United Kingdom to all destinations, and of any of the goods specified in the second schedule hereto from any port in the United Kingdom to any port or destination other than a port or destination to which paragraph 3 of the said Order applies subject to the following condition:-

The owner or skipper of the said goods, if so required by the Commissioners of His Majesty's Customs and Excise, shall produce to them, within such time as they may allow, proof to their satisfaction that the said goods were duly delivered to the destination stated in the shipping documents.

This licence shall come into force on the eighteenth day of September, 1939.
