ROAD AND RAILWAY TRANSPORT. ACQUISITION OF UNDERTAKINGS.

EXTENSION OF PERIOD.

I, the Right Honourable Sir Richard Dawson Bates, Bt., Minister of Home Affairs for Northern Ireland, in pursuance of the powers vested in me by Section 5 of the Road and Railway Transport Act (Northern Ireland), 1935, as amended by Section 3 of the Road Transport Act (Northern Ireland), 1938, and of all other powers in that behalf thereunto enabling me, but without prejudice tc any further exercise of such powers, hereby order and direct that the period within which the Northern Ireland Road Transport Board may acquire every road motor undertaking operated for hire or reward in Northern Ireland, including the passenger and freight Road Transport Services of any railway company operating in Northern Ireland, shall be extended to the 30th day of June, 1940.

GOODS VEHICLES.

MARKETING OF EGGS (DETERMINA-TION OF WHOLESALE DEALERS' PRICES (No. 48) ORDER (NORTHERN IRELAND), 1939.

Notice is hereby given that an Order has been made by the Ministry of Agriculture determining that the prices payable by licensed wholesale dealers for eggs

delivered during the week ended Saturday, 2nd December, 1939, shall be as follows :---

(a) (i) For hen eggs purchased from a producer 1/5^a/₄d. per lb.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional halfpenny per lb. shall be paid.

- (ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 1/6 3-16d. per lb. Deductions:—Seconds 1/2d. per egg; Rejects 21/2d per egg.
- (b) For duck eggs purchased from a producer 2/1d. per dozen. Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order. an additional three-farthings shall be paid for each complete dozen so delivered.

Deductions:--Rejects 2d. per egg.

IN THE PARLIAMENT OF NORTHERN IRELAND-SESSION 1940.

LONDONDERRY HOSPITALS (AMALGAMATION AND GENERAL) BILL.

Notice is hereby given that application is intended to be made to the Parliament of Northern Ireland in the ensuing Session by the Committee of Management of the Londonderry City and County Hospital for leave to introduce a Bill for the following or some of the following purposes:—

To transfer to and vest in the said Committee of Management (in this Notice referred to as the Committee) subject to all debts and liabilities affecting the same the legal and beneficial ownership of all the lands and buildings and other property of the Londonderry City and County Hospital whether now vested in or held upon trust for the Londonderry County and County Borough Councils.

To establish a Maternity Hospital and an Eye Ear and Throat Hospital at the Londonderry City and County Hospital and to provide for the control and management of the same.

To extend the powers conferred upon the Committee by the County Infirmaries (Ireland) Acts, 1765-1833, to include the treatment of women before during and after

childbirth and the promotion of obstetrical science and the treatment of patients suffering from diseases of the eye ear nose and throat.

To provide that as soon as the new Eye Ear and Throat Hospital shall have been opened for the treatment of patients all the property and assets of the Trustees of the Eye Ear and Throat Hospital established at Northland Road in the City of Londonderry shall be transferred to and vested in the Committee and that during the period of construction of the new Eye Ear and Throat Hospital it shall be lawful for the Trustees of the said Eye Ear and Throat Hospital situate at Northland Road, Londonderry, to transfer any part or parts of their funds to the City and County Hospital for expenditure on the building of such new Hospital and the provision of plant and equipment therefor.

To provide for the discharge by the Londonderry City and County Hospital of any debts obligations or liabilities of the Trustees of the said Eye Ear and Throat Hospital at Northland Road, Londonderry, which shall remain undischarged at the date of transfer and for the release and indemnification of such Trustees.

To empower the Committee from time to time to sell, mortgage, charge, exchange or otherwise dispose of the lands buildings and other property and things to be vested in them under the provisions of the proposed Bill or otherwise.

To empower the Committee from time, to time to employ such additional doctors, surgeons, dentists and other officers for the existing Hospital or any extension thereof or for the new Maternity or Eye, Ear and Throat Hospitals.

To empower the Committee to appoint such additional voluntary doctors, surgeons, dentists and other officers to be members of an honorary visiting staff of the said City and County Hospital.

To provide that the Resident Surgeon shall (subject to the direction of the Committee) have full control over the entire medical and aursing staff of the said City and County Hospital and any extension thereof.

To authorise the Committee to contract for the treatment of patients in the said City and County Hospital and to receive payment for such treatment at such rates as may from time to time be fixed by the Committee.

To authorise the Committee to reserve and maintain in the said City and County Hospital or any extension thereof such beds as the Committee may determine for the exclusive accommodation of patients able and willing to pay for treatment therein.

To authorise the Committee to contract for the provision of nurses for patients desirous of nursing treatment elsewhere than in the Hospital building.

To authorise the Committee to give extern relief in medicine surgery and

nursing to sick and wounded persons amongst all classes of the community.

To extend the powers as to granting pensions given to the Committee by Sub-sec (2) of Sec. 1 of the Local Government Act (Northern Ireland), 1923, to include any salaried Officer of the Committee who shall be employed for the purposes of the new Maternity and Eye Ear and Throat Hospitals.

To provide that all persons, companies, firms or other bodies of persons whose members or employees shall be recognised by the Committee as making regular contributions out of their wages towards the funds of the Hospital and all registered medical practitioners shall have the like power to recommend the admission of patients to the said City and County Hospital as is given to the Governors and Governesses by Sec. 9 of the County Infirmaries Act, 1765, and to members of Committee by Sub-sec (1) of Sec. 15 of the Local Government (Ireland) Act, 1898.

To provide that the Committee shall have power and shall be deemed always to have had power to promote Private Bills in Parliament.

To provide for the payment of the costs and expenses of and incidental to the promotion of this Bill.

To provide as to other incidental matters.

Printed copies of the Bill will be deposited in the Private Bill Office of the Parliament of Northern Ireland, on or before 17th day of December next.
