BY THE GOVERNOR OF NORTHERN IRELAND.

ABERCORN.

Whereas by sub-section (3) of section one of the Ministries Act (Northern Ireland), 1940, it is provided that the Governor of Northern Ireland may by order transfer to the Ministry of Public Security established by the said Act (in this order referred to as "the Ministry") from any department any functions exercisable by such department (whether under any enactment or otherwise) in relation to or connected with any of the purposes mentioned in sub-section (2) of the said section, that is to say, public security, civil defence, the preservation of the peace and the maintenance of order, the co-ordination of civil defence services and the protection of persons and property from injury or damage, in the present emergency, or may by order direct that the Ministry and such department shall exercise any of the said functions concurrently:

Now I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, in exercise of the powers conferred upon me by sub-section (3) of section one of the said Act, and of all other powers enabling me in this behalf, do hereby order that the following functions shall be, and are hereby, transferred to the Ministry, that is to say:—

- 1. The functions exercisable by the Ministry of Home Affairs under the Civil Defence Acts (Northern Ireland), 1938 and 1939
- 2. The functions exercisable by the Minister of Home Affairs and the Ministry of Home Affairs in relation to the Royal Ulster Constabulary and to Special Constables whether under the Constabulary Acts (Northern Ireland), 1922 to 1934, or the Special Constables Act, 1914, or otherwise, except functions exercisable under the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 and 1933.

A PROCLAMATION

Revoking a Proclamation appointing Friday, July 12th, nineteen hundred and forty, a Bank Holiday and a Public Holiday in Northern Ireland.

Whereas by a Proclamation dated the mneteenth day of April, nineteen hundred and forty, Friday, the twelfth day of July, nineteen hundred and forty, was appointed

as a special day to be observed as a Bank Holiday and a Public Holiday in Northern Ireland under and in accordance with the Bank Holidays Act, 1871, and the Holidays Extension Act, 1875:

And whereas it is expedient that the said Proclamation should be revoked:

Now, therefore, I, James Albert Edward, Duke of Abercorn, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in pursuance of the said Acts and of all other powers enabling me in that behalf, do hereby revoke the said Proclamation of the nineteenth day of April, nineteen hundred and forty.

GOD SAVE THE KING.

CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 and 1933.

Whereas certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by sub-section (3) of Section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations (a) for making further provision for the preservation of the Peace and Maintenance of Order, and (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule or made as aforesaid, and that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as Regulations contained in the said Schedule;

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Bart., D.L., M.P., Minister of Home Affairs for Northern Ireland, do make the following Regulation for making further provision for the preservation of the Peace and Maintenance of Order, and the said Regulation shall be enforced and have effect in like manner as Regulations contained in the said Schedule, and the said Regulation now made, and the Regulations contained in the said Schedule shall have effect and be construed as if the said Regulations now made formed part of

said Regulations in said Schedule, that is to say:-

IA. (2) On and after the 1st July, 1940, a person who shall have entered Northern Ireland from any place other than another part of the United Kingdom of Great Britain and Northern Ireland shall, if so required by any Constable, satisfy the Police Authorities that his presence in Northern Ireland is essential for the purpose of transacting legitimate business of importance to the national interest of the United Kingdom.

Failure to comply with this Requirement shall be an offence under the Regulations.

ROAD AND RAILWAY TRANSPORT. ACQUISITION OF UNDERTAKINGS: EXTENSION OF PERIOD.
