ADDITIONAL BYE-LAWS AND REGULATIONS

the District, under 'The Dundee Tramways Act, 1872,' and the 'Dundee Street Tramways, Turnpike Roads, and Police Acts, 1878,' and the 'Dundee Street Tramways, Recreation Grounds, Police and Improvement Act, 1887,' and Acts thereby incorporated, for regulating the Traffic on the Roads in which the Tramways are laid.

Whereas obstructions to the Tramway Traffic have been caused by the passage of large Boilers, &c., over the East End Lines of Tramways, it is enacted as

follows :-

First—No Large Boilers, Engines, or extraordinary traffic of that description shall pass over the following Streets or Roads in which Tramways are laid between the hours of 4 A.M. and 6 A.M., and between the hours of 8 A.M. and 11.30 P.M., viz.:—Dura Street, Dens Road, Victoria Road and Meadowside, and Arbroath Road and Victoria Street.

Second—No Carts, Lorries, or other heavy vehicles shall pass up Meadow Place, in which a Tramway was recently laid, but all such traffic shall pass along East Bell Street and the lower part of Victoria Road. This regulation shall not apply to traffic to and from any works or premises in said Meadow Place.

All persons who shall offend against these additional Bye-Laws, or either of them, shall render themselves liable in the penalties prescribed by the Bye-Laws and Regulations now in force as to Tramways.
