to time cause such new denominations of Standards,
being either equivalent to or multiples or aliquot
parts of the Imperial weights and measures ascertained by the said Act, as appear to them to
be required in addition to those mentioned in the
Second Schedule to the said Act, to be made and
duly verified, and that those new denominations
of Standards, when approved by Her Majesty
in Council, shall be Board of Trade Standards
in like manner as if they were mentioned in the
said Schedule:

And whereas it has been made to appear to the Board of Trade that the new denominations of Standards set forth in the Schedule hereto, being equivalent to or multiples or aliquot parts of the Imperial measures ascertained by the said Act, are required, in addition to the denominations of Standards mentioned in the Second Schedule to the said Act:

And whereas they have caused the said new denominations of Standards to be made and duly verified: Now, therefore, Her Majesty, by virtue of the power vested in Her by the said Act, by and with the advice of Her Privy Council, is pleased to approve the several denominations of Standards set forth in the Schedule hereto as new denominations of Standards, and doth direct that the same, on and after the first day of January 1890, be Board of Trade Standards in like manner as if they were mentioned in the Second Schedule to 'The Weights and Measures Act, 1878.'

(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

- 1. The following Area,—namely, the Burgh of Dysart, which was declared, by Order of the Privy Council, dated the thirteenth day of July one thousand eight hundred and eighty-nine, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuro-pneumonia.
- 2. This Order shall take effect from and immediately after the thirtieth day of November one thousand eight hundred and eighty-nine.

In witness whereof the Board of Agriculture have hereunto set their Official Seal this twenty-ninth day of November one thousand eight hundred and eighty-nine.

The Board of Agriculture, acting under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, hereby authorise the Local Authority for the County of Fife to put in operation, within seven days after the date of this Authority, Article 6 of The Animals (Amendment) Order of 1887, dated the twenty-third day of March one thousand eight hundred and eighty-seven, providing for the slaughter by Local Authorities of cattle suspected of pleuro-pneumonia, and the payment of compensation for the same, in respect of a certain cow suspected of being affected with pleuro-pneumonia, the property of Mr. John Duncan, of Balmerino.

This Authority is revocable by the Board of Agriculture.
