Patent to be passed under the Great Seal of the United Kingdom of Great Britain and Ireland appointing the Right Honourable Sir Michael Morris, Bart., Lord Chief Justice of Ireland, to be a Lord of Appeal in Ordinary, under the provisions of 'The Appellate Jurisdiction Act, 1876,' and to grant to him the dignity of a Baron for life, by the style and title of Baron Morris of Spiddal, in the County of Galway.

WHITEHALL, December 5, 1889.

The Queen has been pleased to give and grant unto Sir Edgar Vincent, K.C.M.G., Her Royal licence and permission that he may accept and wear the Insignia of the Order of the Osmanich of the First Class, which His Highness the Khedive of Egypt, authorised by His Imperial Majesty the Sultan, has been pleased to confer upon him, in recognition of his services whilst actually and entirely employed beyond Her Majesty's dominions in the service of the Egyptian Government.
