A PROCLAMATION,

In order to the Electing two Peers of Scotland.

VICTORIA, R.

HEREAS the Right Honourable Alexander, Earl of Leven and Melville, and the Right Honourable George William Hamilton, Earl of Orkney, were duly elected and returned to be two of the Sixteen Peers of Scotland to sit in the House of Peers in the present Parliament of the United Kingdom of Great Britain and Ireland, and are since deceased: In order to the Electing two other Peers of Scotland to sit in their room, We do, by the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood House, at Edinburgh, on Monday the sixth day of January, one thousand eight hundred and ninety, between the hours of twelve and two in the afternoon, to nominate and choose two other Peers of Scotland to sit and vote in the House of Peers in this present Parliament of the United Kingdom of Great Britain and Ireland, in the room of the said Alexander, Earl of Leven and Melville, and George William Hamilton, Earl of Orkney, deceased, by open election and plurality of voices of the Peers that shall be then present, and of the proxies of such as shall be absent (such proxies being Peers and producing a mandate in writing duly signed before witnesses, and both the constituent and proxy being qualified according to law): and the Lord Clerk Register, or the two Principal Clerks of the Session appointed by him

to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the names of the Peers so elected, and to sign and attest the same in the presence of the said Peers, the electors, and return such certificate into Our High Court of Chancery of Great Britain: and We strictly charge and command that this Our Royal Proclamation be duly published at the Market Cross at Edinburgh, and in all the county towns of Scotland, ten days at least before the time hereby appointed for the meeting of the said Peers to proceed on such election.

Given at Our Court at Windsor, this thirteenth day of December, in the year of our Lord one thousand eight hundred and eighty-nine, and in the fifty-third year of Our Reign.

LOCAL GOVERNMENT (SCOTLAND) ACT, 1889.

COUNTY COUNCIL ELECTIONS.

Order by the Secretary for Scotland, under Section 108.

THE Most Honourable Schomberg Henry, Marquis of Lothian, K.T., Her Majesty's Secretary for Scotland, considering that certain difficulties have arisen as to holding the first Election of County Councillors in Scotland, in pursuance of the Local Government (Scotland) Act, 1889, and that it is necessary to remove such difficulties, Do hereby, in virtue of the powers vested in me by Section one hundred and eight of the before-mentioned Act, Order as follows:—

- 1. Any notice required by the Acts regulating Municipal Elections in Scotland, or by the Ballot Act, 1872, or by the Local Government (Scotland) Act, 1889, to be given within a certain time, shall be deemed to be duly given if it is delivered at any Post Office in Scotland within the statutory period, addressed to the Police Officer, or other person who is directed by the Returning Officer or his Deputy to post up the same, and is posted up as required by law as soon as practicable after receipt thereof by such officer or other person.
- 2. The nomination papers shall be delivered for the County Clerk at such office or place as the Returning Officer may specify in the Notice of Election, and may be delivered by any person, or may be sent by post, provided always that they are actually delivered at the specified office or place, not later than four o'clock afternoon on the second Tuesday preceding the day of Election. Any Elector who sends to the Returning Officer or County Clerk an envelope stamped and addressed, shall have a form of Nomination Paper posted to him.
- 3. The Ballot Boxes and other requisites for the Election, properly sealed up and secured, may, where practicable, be sent to the Presiding Officers by Parcels Post, or by such other mode of conveyance as may be approved of by the Returning Officer or his Deputy; and after the poll, the Ballot Boxes, Ballot Papers, and other documents and things required to be transmitted to the Returning Officer or his Deputy, properly sealed up and secured, may in like manner be transmitted to such Returning Officer or his Deputy.
- 4. It shall be no objection to the use of a stamping instrument at an Election, that the official mark on it has been used at an Election in the same County within the previous seven years, nor shall it be necessary to have the same official mark for all the Electoral Divisions in a County, provided always that within each Electoral Division only one official mark shall be used.
- 5. Immediately on the receipt of the Ballot Box or Boxes from any Electoral Division, or as soon thereafter as may be convenient, the Returning Officer or his Deputy may, without regard to the hour, count the votes for that Division, and forthwith declare the result of the poll therefor. The votes may be counted and the results of the polls

declared at any place which the Returning Officer may appoint. The declaration of the due Election of Candidates returned unopposed shall be made on the day succeeding the Election, at the place appointed for the counting of the votes.

- 6. Where the number of voters appointed to poll at any polling station does not exceed 300, it shall not be necessary for the Returning Officer or his Deputy to appoint a Poll Clerk to act at such polling station.
- 7. Presiding Officers, Clerks, and Assistants shall be deemed] to be properly appointed and authorised to act in or for any Electoral Division, if their names be contained in a List, entitled 'Presiding Officers for the County Council Election of shire' (or as the case may be), and subscribed by the Returning Officer or his Deputy; and a circular addressed to these persons respectively intimating their appointment by the Returning Officer or his Deputy, or by the Sheriff Clerk or his Depute, shall be deemed sufficient evidence of such appointments if challenged.

deposited with them, and hereinafter collectively referred to under the term 'goods,' in or upon any wharf, warehouse, shed, store, land, or premises of the firms respectively, or to persons entitled to goods so warehoused, stored, or deposited, certificates of such goods having been so warehoused, stored, or deposited, or warrants for the delivery of such goods, or any portion or

portions thereof.

To provide that every such certificate or warrant shall be deemed to be a document of title to the goods specified therein, and transferable by endorsement; and further, to provide that any holder of such certificate or warrant, whether the person named therein or the endorsee thereof shall have the same right to the possession and property of such goods as if they were deposited in or upon his own wharf, warehouse, shed, lands, or premises, and to make other provision for the issue of negotiable certificates and warrants, and for defining the property in the goods, and the rights of the holders of such certificates or warrants. FORTH BRIDGE RAILWAY.

(Additional Capital and Borrowing Powers to Company and Provisions relating to Capital; Provisions as to Payment of Interest on Calls, and as to Guarantee of North British, Midland, North-Eastern, and Great Northern Railway Companies, and as to Interest Fund; Powers to the Four before-mentioned Companies to contribute Money and guarantee Interest and Dividends on Capital of Company and to apply Funds, and to raise Money; Confirmation of Agreements; Incorporation of Acts; Amendment of Acts; and other Purposes.)

OTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session for leave to bring in a Bill for all or some of the following objects, powers,

and purposes (that is to say):

r. To empower the Forth Bridge Railway Company (hereinafter called 'The Company') to increase their Capital, and to raise further monies for the general purposes of their undertaking by the creation and issue of new shares or stock, and by borrowing and by the creation and issue of debenture stock, or by any of those means; and, if need be, to alter and regulate the Capital of the Company.

2. To alter and amend Section 41 of the Forth Bridge Railway Act, 1882 (in this notice called the Act of 1882'), as to the guarantee to be given by the North British Railway Company, the Midland Railway Company, the North-Eastern Railway Company, and the Great Northern Railway Company (in this notice called 'the four Companies') to make up deficiency in the income of the Company, and to extend that guarantee to the additional capital to be raised under the Bill, and to make the provisions of that Section applicable with or without modification to the said additional capital, and to the payment of interest or dividend thereon, and to make provision for the payment to be made by the four Companies, in respect of such deficiency, and the repayments to be made by the Company, and to make such other provisions with respect to the matters aforesaid, and the several matters referred to in that section, as the Bill may provide or Parliament may sanction.

3. To authorise and require the four companies, previous to the opening of the Forth Bridge Railway, or after the opening, or both, to contribute and pay, or otherwise guarantee to the Company, such annual or other payments, and in such proportions as have been agreed upon between them and the Company, or may, previous to the passing of the Bill, be agreed upon, and to provide in certain circumstances for the repayment of such contributions and payments, and guarantee moneys, and to make such other provisions with respect to the several matters aforesaid, as the Bill may provide or Parliament

sanction.

4. To apply all or any part of the premiums already received or to be received by the Company, on the issue of their shares or stock, debentures, or debenture stock, to the interest fund mentioned in the said Section 41, and to make such other and further provisions with respect to the matters therein referred to, and to the disposal of the said premiums as the Bill may provide or Parliament may sanction.

5. To empower the four Companies, to apply to the purposes aforesaid, or any of them, any capital or funds now belonging, or which may hereafter respectively belong, to the four Com-

panies, or any or either of them.

6. To confirm and give effect to any agreement or agreements already made, or which previously to the passing of the Bill may be made touching any of the matters mentioned in this notice.

7. The Bill will vary and extinguish all existing rights and privileges inconsistent with, or which would or might in any way impede or interfere with, any of the objects aforesaid, and of the Bill being carried into effect; and will confer all other rights and privileges necessary or expedient for effecting the said objects, or in relation thereto, and will incorporate with itself the necessary provisions of 'The Companies Clauses Consolidation (Scotland) Act, 1845,' 'The Companies Clauses Act, 1863,' and 'The Companies Clauses Act, 1869.'

8. The Bill will also repeal, alter, vary, enlarge, or amend all or some of the powers and provisions of 'The Forth Bridge Railway Act, 1873,' 'The Forth Bridge Railway Act, 1876,' 'The Forth Bridge Railway Act, 1878,' 'The Forth Bridge Railway Act, 1879,' 'The Forth Bridge Railway Act, 1882,' 'The Forth Bridge Railway Act, 1886,' and 'The Forth Bridge Railway Act,

1888, 'The North British Railway (Fife Railways) Act, 1876, 'The North British, Edinburgh, Perth, and Dundee and West of Fife Railways Amalgamation Act, 1862, and any other Acts relating to the Company.

9. The Bill will also repeal, alter, or amend, all or some of the provisions of the several Acts of Parliament following, or some of them, that is to

say :-
