BYE-LAWS AND REGULATIONS

MADE BY THE

BOARD OF POLICE OF THE BURGH OF GREENOCK.

As the Local Authority, under Section 46 OF THE TRAMWAYS ACT, 1870.

1. For the purpose of these Bye-Laws and Regulations the term 'Car' shall mean any carriage using any tramway laid down within the said Burgh, and the term 'Conductor' shall mean the guard, conductor, or

tramway laid down within the said Burgh, and the term 'Conductor' shall mean the guard, conductor, or other person having charge of a car.

2. The driver of every car shall drive or cause the same to be driven at a speed of not less than four miles an hour on the average, and not exceeding eight miles an hour, except in Main Street, where the rate of speed shall not exceed five miles an hour, and in Cathcart and Hamilton Streets respectively, where the rate of speed shall not exceed six miles an hour.

3. The driver of every car shall so drive the same that it shall not follow a preceding car at a less distance than one hundred yards.

4. Subject to the requirements of Bye-Laws No. 3 and 5, the driver or conductor of a car shall stop the same for the purpose of setting down or taking up passengers, when required by any passenger desiring to leave the car, or by any person desirous of travelling by the car, for whom there is room, and to whose admission no valid objection can be made, and also when required by any constable for any purpose: provided that nothing in this Bye-Law shall require a car to be stopped on any gradient steeper than 1 in 25.

5. Except in case of accident or obstruction no car nor any animal attached thereon shall be stopped at the intersection or junction of two or more streets or roads, nor within ten yards of a car on an adjoining line of rails, nor opposite the cart or carriage entrance to any

intersection or junction of two or more streets or roads, nor within ten yards of a car on an adjoining line of rails, nor opposite the cart or carriage entrance to any dock, quay, wharf, warehouse, yard, building premises or place, nor upon nor within twelve feet of any line of railway crossing any tramway on the road or street level.

6. The driver of a car, on coming in sight of a vehicle standing or travelling on any part of the road so as not to leave sufficient space for the car to pass, shall sound his bell or whistle as a warning to the person in charge of such vehicle, and that person shall, with reasonable dispatch, cause such vehicle to be removed so as not to obstruct the car.

7. No person shall in any way, without reasonable and

7. No person shall in any way, without reasonable and sufficient cause, wilfully impede or interfere with the traffic on the tramways, nor shall any car driver or conductor needlessly cause interruption to the ordinary

conductor needlessly cause interruption to the ordinary road traffic.

8. When a red flag is exhibited during daylight or a red light during darkness by any constable or person stationed or standing at or near any place where any line of railway crosses any tramway on the road or street level every driver of a car or other vehicle of any description proceeding in the direction of such railway crossing,

shall stop the car or vehicle under his charge, and any animal drawing the same, at a distance of not less than twelve feet from such railway crossing, and there remain till permitted by such constable or person to pass; and no driver of any locomotive engine or train shall, with such engine or train, cross or attempt to cross any such tramway till sufficent time and warning have been given as above to the drivers of cars and other vehicles to stop as above or otherwise to remove the same out of the way

of such engine or train.
