**W**HEREAS Her Majesty was pleased, by an Order in Council dated the 26th day of June 1884, and by various subsequent Orders, to declare that certain provisions of the Patents, Designs, and Trade Marks Act, 1883, should apply to the several Countries and Colonies mentioned in such Orders;

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and by virtue of the authority committed to Her by the said Act, doth declare, and it is hereby declared, that the provisions of the said Act hereinbefore referred to, as amended by the Patents, Designs, and Trade Marks (Amendment) Act, 1885, shall also apply to the following Colonies of the Netherlands, viz.:

Curacoa and Surinam.

And it is hereby further ordered and declared that this Order shall take effect, so far as regards Patents, at the expiration of seven months, and so far as regards Designs and Trade Marks, at the expiration of four months from the day and date first above written.

## COUNTY OF PERTH.

Order by the Secretary for Scotland, under Section 108 of the Local Government (Scotland) Act, 1889, with regard to the formation of Districts.

Whereas by Section 77, sub-section 1, of the Local Government (Scotland) Act, 1889, it is provided that the County Council shall, at their first Meeting in the month of May next after the passing of the Act, and thereafter from time to time, divide the County into Districts for the purposes in the said Section mentioned, in such manner that each District shall comprise a group of Electoral Divisions, and that each Parish, so far as within the County, shall be wholly included in one District; and whereas in certain Counties there are Parishes with detached parts thereof situated within the County, but at such distance from the main part as to render it inexpedient, when the County is to be divided into Districts, that such detached portions should be included in the same District as the main parts of the Parishes; and whereas by Section 108, sub-section 2, of the said Local Government Act, it is provided that the Secretary for Scotland, on the application of a County Council or Provisional Council, may, within six months after the date fixed for the first Election of Councillors of such Council, from time to time make such Orders as appear to him to be necessary for bringing the

Act into full operation as respects the Council so applying, and such Orders may modify any enactment in the said Act, or in any other Act, whether general or local and personal, so far as may appear to the Secretary for Scotland necessary for the said purpose; and whereas the Provisional County Council for the County of Perth have made application to me to modify the enactment in Section 77 of the said Act before referred to, to the extent after mentioned, so as to allow the Act to come into full operation in regard to the formation of Districts,—Therefore I do hereby order and direct, that until the Boundary Commissioners appointed by the said Act shall have dealt with and determined as to the hereinafter mentioned Electoral Divisions and detached parts of Parishes,—

(1). Notwithstanding the recited enactment in Section 77 of the said Act, the County Council of the County of Perth may, if so advised, resolve to include in the Blairgowrie or Eastern District of the said County (a) the detached part of the Parish of Scone, as if it were part of the Parish of Cargill; (b) the detached part of the Parish of Kinnoull, in which Balbeggie is situated, as if it were part of the Parish of St. Martins; and (c) the detached part of the Parish of Dunkeld and Dowally, which contains part of the Town of Dunkeld, as if it were part of the Parish of Caputh.

(2). Further, the County Council of the said County may, if so advised, resolve to include that part of the Electoral Division of Dunkeld which is situated in Caputh Parish, including part of Dunkeld and Dowally, as above, in the Blairgowrie or Eastern District of the said County, and the remaining portion of the said Electoral Division in the Highland District of the said County.

(3). Further, the County Council of the said County may, if so advised, resolve to include that part of the Electoral Division of Ardoch which is situated within the Parish of Dunblane, within the Western District of the said County, and those parts of the said Electoral Division which are situated within the Parishes of Muthill and Blackford, within the Central District of the said County.

(4). Further, if the County Council shall resolve in terms of the powers granted in above Order numbered (2), then the County Councillor for the Dunkeld Electoral Division shall be a Member of the District Committee of the Blairgowrie or Eastern District of the said County; and if they resolve in terms of the powers granted in above Order numbered (3), then the County Councillor for the Ardoch Electoral Division shall be a Member of the District Committee of the Western District of the said County.
