(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

- 1. The following Place (namely)—the cow-shed or byre, with the whole buildings and grounds adjoining or near thereto, in the occupation of Jane Robertson, and situate at Balbirnie Place, Edinburgh, which was declared by Order of the Local Authority for the Burgh of Edinburgh, dated the eleventh day of September one thousand eight hundred and ninety, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.
- 2. This Order shall take effect from and immediately after the thirtieth day of September one thousand eight hundred and ninety.
