OTICE is hereby given that the Secretary for Scotland has this day, in pursuance of section 6, sub-section 2, of the Herring Fishery (Scotland) Act, 1889, confirmed the following Bye-Law passed by the Fishery Board for Scotland, viz:—

Bye-Law (No. 8) made by the Fishery Board for Scotland, under the powers conferred on the Board by the Sea Fisheries (Scotland) Amendment Act, 1885, the Herring Fishery (Scotland) Act, 1889, and the Herring Fishery (Scotland) Act Amendment Act, 1890.

I. Whereas by the Act 52 and 53 Vict. cap. 23, being the aforesaid Herring Fishery (Scotland) Act, 1889, it is enacted that the Fishery Board for Scotland may by Bye-Law or Bye-Laws direct that the method of fishing known as beam trawling, or otter trawling, shall not be used within a line drawn from Duncansby Head, in Caithness, to Rattray Point, in Aberdenshire, in any area or areas to be defined 'in such Bye-Law,' it is hereby declared that the area to which the foregoing provision shall apply is the portion of the waters above specified, inside of a straight line drawn from the Ord of Caithness to Craighead, near Buckie.

II. Within the aforesaid area, as above defined,

no person, unless in the service or possessing the written authority of the said Fishery Board for Scotland, under the hand of the Secretary thereof, shall at any time, from the date when this Bye-Law shall come into force, use any beam trawl or otter trawl for taking sca-fish; and any person acting in contravention of this Byc-Law, shall be liable, on conviction under the Summary Jurisdiction (Scotland) Acts, to a fine not exceeding One Hundred Pounds, and failing immediate payment of the fine, to imprisonment for a period not exceeding sixty days, without prejudice to diligence by poinding or arrestment, if no imprisonment has followed on the conviction; and every net set, or attempted to be set, in contravention of the said Bye-Law, shall be forfeited, and may be seized and destroyed, or otherwise disposed of by any superintendent of the herring fishery, or other officer employed in the execution of the Herring Fishery (Scotland) Acts, all in terms of the said

III. This Bye-Law shall come into force from and after the date of its confirmation by the Secretary for Scotland.

And whereas a part of the Parish of Weem, containing 191 acres or thereby, situated at or near Bridge of Lochay and adjoining the Parish of Killin and a detached part of the Parish of Kenmore (being marked on the Ordnance Survey Maps Weem detached No. 1), is detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 2993 acres or thereby, situated at or near Achmore and adjoining the Parishes of Killin and Comrie and a detached part of the Parish of Kenmore (being the part marked on the Ordnance Survey Maps Weem detached No. 2), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 3125 acres or thereby, situated at or near Duncroisk and adjoining the Parishes of Killin and Fortingall and detached parts of the Parish of Kenmore (being the part marked on the Ordnance Survey Maps Weem detached No. 3), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 11,731 acres or thereby, extending from Balnahanaid southwards to Loch Tay and adjoining the Parishes of Fortingall and Kenmore and a detached part of the Parish of Killin (being the part marked on the Ordnance Survey Maps Weem detached No. 4), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 453 acres or thereby, situated at or near Comrie Castle and adjoining the Parishes of Kenmore, Dull, and Fortingall (being the part marked on the Ordnance Survey Maps Weem detached No. 5), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 345 acres or thereby, situated at or near Newhall and adjoining the Parishes of Dull and Kenmore (being the part marked on the Ordnance Survey Maps Weem detached No. 6), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 573 acres or thereby, situated at or near Stix and adjoining the Parish of Dull and a detached part of the Parish of Fortingall (being the part marked on the Ordnance Survey Maps Weem detached No. 7), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 568 acres or thereby, situated at or near Leachan north of the river Quaich and adjoining the Parishes of Dull and Kenmore and a detached part of the Parish of Fortingall (being the part marked on the Ordnance Survey Maps Weem detached No. 8), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 17,310 acres or thereby,

situated at or near Lubreoch and Kenknock, and adjoining the Parishes of Fortingall and Killin and detached parts of the Parish of Kenmore (being the part marked on the Ordnance Survey Maps Weem detached No. 9), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem, containing 2207 acres or thereby, situated at or near Duntaggart and adjoining the Parishes of Little Dunkeld and Dull and a detached part of the Parish of Logierait (being the part marked on the Ordnance Survey Maps Weem detached No 10), is also detached from the main portion of the Parish of Weem; and another part of the Parish of Weem; and another part of the Parish of Weem, containing 945 acres or thereby, situated at or near Coalvellich and adjoining detached parts of the Parishes of Dull, Monzie, and Kenmore (being the part marked on the Ordnance Survey Maps Weem detached No. 11), is also detached from the main portion of the Parish of Weem:

And whereas it appears to us, after communicating with the Authorities and others interested, and considering all objections to the terms of our Draft Order thereanent, to be expedient to alter and adjust, in manner hereinafter provided, the Boundaries of the said Parishes of Blair Athole, Dull, Dunkeld & Dowally, Fortingall, Kenmore, Killin, Logierait, Moulin, and Weem:

Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows:—

- I. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Dunkeld & Dowally marked on the Ordnance Survey Maps Dunkeld & Dowally detached No. 1, shall cease to be part of that Parish, and shall form part of the Parish of Logierait.
- II. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Moulin marked on the Ordnance Survey Maps Moulin detached No. 1, shall cease to be part of that Parish, and shall form part of the Parish of Logierait.
- III. Subject to the provisions of the said Act, that part of the Parish of Logierait consisting of the estate of Fonab, bounded on the north by the Parish of Moulin, on the east by the lands of Dunfallandy, on the south by the lands of Ballechin, and on the west by the lands of Cluny, shall cease to be part of the Parish of Logierait, and shall form part of the Parish of Moulin.
- IV. Subject to the provisions of the said Act, that part of the Parish of Blair Athole forming the estate of Reinakyllich, bounded on the west by the stream Aldgirnaig, on the north by the lands of Shinigag, on the east by the lands of Conacraig, and on the south by the lands of Urrard, shall cease to be part of the Parish of Blair Athole, and shall form part of the Parish of Moulin.
- V. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Moulin, marked on the Ordnance Survey Maps Moulin detached No. 2, shall cease to be part of that Parish, and

shall form part of the Parish of Blair Athole.

VI. Subject to the provisions of the said Act, so much of the Parish of Dull as lies to north of the river Tummel and of Loch Tummel shall cease to be part of that Parish, and shall form part of the Parish

of Blair Athole.

VII. Subject to the provisions of the said Act, that portion of the Parish of Dull situated at or near Grandtully and bounded on the north by the river Tay, on the east and south by the Parish of Little Dunkeld, and on the west by the aforesaid detached part of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 10, shall cease to be part of the Parish of Dull, and shall form part of the Parish of Logierait.

VIII. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 10, shall cease to be part of that Parish, and shall form

part of the Parish of Logierait.

IX. Subject to the provisions of the said Act, the aforesaid detached parts of the Parish of Logierait, marked on the Ordnance Survey Maps Logierait detached No. 1 and Logierait detached No. 2, and also so much of the aforesaid detached part of the Parish of Logierait marked on the Ordnance Survey Maps Logierait detached No. 5, as lies to the north of the river Tay, shall cease to be part of the Parish of Logierait, and shall form part of the Parish of Weem.

X. Subject to the provisions of the said Act, so much of the Parish of Dull as lies to the east of the main portion of the Parish of Weem, to the north of the river Tay, to the west of the main portion of the Parish of Logierait, and to the south of the watershed between Strathtummel and Strathtay (including the lands of Glassie, Cluny, and Derculich), shall cease to be part of the Parish of Dull, and shall form

part of the Parish of Weem.
XI. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Fortingall marked on the Ordnance Survey Maps Fortingall No. 1, shall cease to be part of that Parish, and shall form

part of the Parish of Dull.

XII. Subject to the provisions of the said Act, the aforesaid detached parts of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 5, Weem detached No. 6, Weem detached No. 7, Weem detached No. 8, and Weem detached No. 11, shall cease to be part of the Parish of Weem, and shall form part of the Parish of Dull.

XIII. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Kenmore marked on the Ordnance Survey Maps Kenmore detached No. 4, shall cease to be part of that Parish, and shall form part of the parish of Dull.

XIV. Subject to the provisions of the said Act, so much of the aforesaid detached parts of the Parish of Logierait marked on the Ordnance Survey Maps Logierait detached No. 5, as lies to the south of the river Tay, shall cease to be part of that Parish, and shall form part of the Parish of Dull.

XV. Subject to the provisions of the said Act, the aforesaid detached parts of the Parish of Logierait marked on the Ordnance Survey Maps Logierait detached No. 3 and Logierait detached No. 4, shall cease to be parts of that Parish, and shall form

part of the Parish of Fortingall. XVI. Subject to the provisions of the said Act, so much of the Parish of Kenmore on the

north of Drummond Hill as lies north of the watershed between Glen Lyon and Loch Tay shall cease to be part of that Parish, and shall form part of the Parish

of Fortingall.

XVII. Subject to the provisions of the said Act, so much of the aforesaid detached part of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 4, as lies to the north of the watershed between Loch Tay and Glen Lyon, shall cease to be part of the Parish of Weem, and shall form part of the Parish of Fortingall; and so much of the said detached part as lies to the south of the said watershed shall cease to be part of the Parish of Weem, and shall form part of the Parish of Kenmore.

XVIII. Subject to the provisions of the said Act, so much of the aforesaid detached part of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 9, as lies to the north of the watershed between Glen Lochay and Glen Lyon, shall cease to be part of the Parish of Weem, and shall form part of the Parish of Fortingall; and so much of the said detached part as lies to the south of the said watershed shall cease to be part of the Parish of Weem, and shall form part

of the Parish of Killin.

XIX. Subject to the provisions of the said Act, so much of the aforesaid detached part of the Parish of Kenmore marked on the Ordnance Survey Maps Kenmore detached No. 5, as lies to the north of the watershed between Glen Lochay and Glen Lyon, shall cease to be part of the Parish of Kenmore, and shall form part of the Parish of Fortingall; and so much of the said detached part as lies to the south of the said watershed shall cease to be part of the Parish of Kenmore, and shall form

part of the Parish of Killin. XX. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Killin marked on the Ordnance Survey Maps Killin detached No. 2, shall cease to be part of that Parish, and shall form

part of the Parish of Kenmore.

XXI. Subject to the provisions of the said Act. the aforesaid part of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 2, shall cease to be part of that Parish, and shall form part of the Parish of Kenmore.

XXII. Subject to the provisions of the said Act, the aforesaid detached parts of the Parish of Kenmore marked on the Ordnance Survey Maps Kenmore detached No. 1 and Kenmore detached No. 2, shall cease to be part of that Parish, and shall form part of the Parish of Killin.

XXIII. Subject to the provisions of the said Act, the aforesaid detached parts of the Parish of Weem marked on the Ordnance Survey Maps Weem detached No. 1 and Weem detached No. 3, shall cease to be part of that Parish, and shall form part of the Parish of Killin.

XXIV. Subject to the provisions of the said Act, so much of the area marked on the Ordnance Survey Maps "Land common "to the Parishes of Blair Athole, Fort-"ingall, and Logierait detached No. 4," as lies north of Allt Sleibh shall form part of the Parish of Blair Athole, and so much of the area as lies to the south of the said Allt Sleibh shall form part of the Parish of Fortingall.

XXV. Nothing in this Order shall affect the School Districts of Amulree Innerwick (Glen Lyon), Kinloch-Rannoch, and Tenandry, or the powers, duties, and liabilities of the School Boards of the said Districts, or the mode of electing the said School Boards, or the Registration Districts of Innerwick (Glen Lyon), Kinloch-Rannoch, and Tenandry.

XXVI. This Order shall come into operation for the purposes of School Board elections on the 1st day of February 1891, and for all other purposes on the 15th day of May 1891.

Whereas part of the Parish of Dornoch, extending to 725 acres or thereby, situated at or near Kinnauld and adjoining the Parishes of Golspie and Rogart, is, as shown on the Ordnance Survey Maps, detached from the main portion of the Parish of Dornoch:

And whereas it appears to us, after communicating with the Authorities and others interested, to be expedient to alter and adjust the Boundaries of the said Parishes of Dornoch and Rogart in manner hereinafter provided:

Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows:—

I. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Dornoch shall cease to be part of that Parish, and shall form part of the Parish of Rogart.

II. Subject to the provisions of the said Act, so much of the Parish of Rogart as lies to the south of a line starting at a point on the boundary between the Parishes of Dornoch and Rogart at the head of Allt Reidh Chalmac and running in a generally westerly direction first to Craig-a-bhlair, thence along the watershed between Strath Fleet on the north and Strath Carnach and Strath Tollaidh on the south (the said line running along the top of the Droigneach Hills to Meall Mhor, and thereafter to the north of Lochan a Ghiubhais and over Cnoc Lochan Iain Bhuidhe, and Creagan Glas), to a knoll a little to the east of Loch na Saobhaidhe, from which knoll it runs direct in a southwesterly direction to the forkings at the head of Allt an Cealgaiche, and thence down the said burn until it meets the boundary of the Parish of Creich, shall cease to be part of the Parish of Rogart, and shall form part of the Parish of Dornoch.

III. This Order shall come into operation for the purposes of School Board elections on the 31st day of March 1891, and for all other purposes on the 15th day of May 1891.
