I, THE Most Honourable Schomberg Henry, Marquess and Earl of Lothian, K.T., Her Majesty's Secretary for Scotland, having carefully considered the prayer of the Memorial laid before me by the District Board of the River Tay, in terms of the 9th Section of the Salmon Fisheries (Scotland) Act, 1868, for an alteration of the annual close time for Rod Fishing applicable to the said District, and being satisfied that the requisite statutory formalities have been duly complied with by the said District Board, and that it is expedient and desirable that the annual close time for Rod Fishing applicable to the District of the River Tay should be altered, do hereby, in virtue of the powers conferred upon me by the Salmon Fisheries (Scotland) Act, 1868, as read with the Secretary for Scotland Act, 1885, order, in terms of the prayer of the said Memorial, that the annual close time for Rod Fishing applicable to the River Tay and its tributaries (with the exception of the Earn) shall be altered, so that the period for Rod Fishing shall in future be from the 15th day of January to the 15th day of October, both days inclusive, in each year; and I further order that the annual close time for Rod Fishing applicable to the River Earn and to its tributaries shall continue as at present, so that the period for Rod Fishing applicable to that River and its tributaries shall be from the 11th day of February to the 31st day of October, both days inclusive, in each year; and I do hereby direct that this Order shall be published in the Edinburgh Gazette of Friday, 19th December 1890.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

- 1.
