

NOTICE is hereby given that His Royal Highness The Prince of Wales will, by command of The Queen, hold a Levee at St. James's Palace, on behalf of Her Majesty, on Saturday the 27th instant, at two o'clock.

It is The Queen's pleasure that Presentations to His Royal Highness at the Levee shall be considered as equivalent to Presentations to Her Majesty.

#### REGULATIONS

TO BE OBSERVED AT THE QUEEN'S LEVEE TO BE HELD BY HIS ROYAL HIGHNESS THE PRINCE OF WALES, ON BEHALF OF HER MAJESTY, AT ST. JAMES'S PALACE.

By Her Majesty's Command,

Gentlemen who propose to attend Her Majesty's Levee are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

#### PRESENTATIONS.

Gentlemen who propose to present others must send in writing the name of such Gentlemen to the Lord Chamberlain's Office, not later than two days previous to the Levee, in order that the Lord Chamberlain may submit the names to Her Majesty, when, if they are approved, Presentation

Cards will be forwarded. Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

It is particularly requested that the names of the Gentlemen to be presented be very distinctly written on the Presentation Cards delivered to the Lord Chamberlain at the Levee, in order that there may be no difficulty in announcing them to His Royal Highness.

Order by the Secretary for Scotland, under section 108 of the Local Government (Scotland) Act, 1889, with reference to the Long Island Road Districts.

Whereas it has been represented to the Secretary for Scotland by the County Council of the County of Inverness, that, in order to bring the Local Government (Scotland) Act, 1889, into full operation as respects that County, it is necessary that under the powers conferred on him by section 108 (2) of the aforesaid Act he should make an order modifying the provisions contained in section 18 of the Roads and Bridges Act, 1878, as read with sections 16, 17, and 77 (1) of the Local Government (Scotland) Act, 1889, in regard to the formation of two of the existing districts in

the Long Island into one district for the purposes of the Local Government (Scotland) Act, 1889.

Now, therefore, I, the Most Honourable Schomberg Henry, Marquess and Earl of Lothian, K.T., Her Majesty's Secretary for Scotland, hereby make the following Order, viz.:—

That the districts of South Uist and Barra, as at present constituted, shall, as from the 15th day of May 1891, be deemed to be one district of the County of Inverness, in the same manner, to the same effect, and for the same purposes as if they had been formed into one district by the County Council of that County in pursuance of and subject to the provisions of sections 16, 17, and 77 (1) of the Local Government (Scotland) Act, 1889.

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The

Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

- 1. The following Place (namely)—in the Burgh of Edinburgh, comprising the cow-byre, stable, straw-shed, yard, and other premises at 52 Gorgie Road, together with the land known as Dalry Meadows, in the occupation of Mr. Alexander Begbie, cowfeeder, which was declared by Order of the Board, dated the eighth day of June one thousand eight hundred and ninety-one, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.
- 2. This Order shall take effect from and immediately after the seventeenth day of June one thousand eight hundred and ninety-one.

In witness whereof the Board of Agriculture have hereunto set their Official Seal this sixteenth day of June one thousand eight hundred and ninety-one.

(PLEURO-PNEUMONIA SCHEDULED DISTRICT.)

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do hereby revoke their Order, bearing date the twenty-first day of April one thousand eight hundred and ninety-one, declaring parts of Aberdeenshire and Banfishire, with the Burgh of Peterhead, to be a Pleuro-Pneumonia Scheduled District: Provided that nothing herein shall be deemed to revive the Orders revoked by or otherwise affect the past operation of the Order hereby revoked, or invalidate or make unlawful anything done under the said Order hereby revoked before the date when this Order takes effect, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order hereby revoked before the date when this Order takes effect.

This Order shall take effect from and immediately after the twenty-third day of June one thousand eight hundred and ninety-one.
