THE ANIMALS (AMENDMENT) ORDER OF 1892, No. 4.

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Revocation of Orders.

1. The Orders described in the Schedule to this Order, to the extent described in that Schedule, are hereby, from and after the commencement of this Order, revoked: Provided that such revocation shall not revive any part of any Order revoked by or otherwise affect the past operation or invalidate or make unlawful anything done under such part hereby revoked, before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, any part of any Order hereby revoked before the commencement of this Order.

Cattle from Isle of Man to be free.

2. Chapter 34 (Isle of Man) of the Animals Order of 1886 shall, from and after the commencement of this Order, apply to cattle as well as to other animals brought from the Isle of Man, as if the Animals (Amendment) Order of 1891 had not been made.

Amendment of Article 151 of The Animals Order of 1886.

3. The following provisions of this Article shall be read in the place of Article 151 of the Animals Order of 1886, and shall be deemed to be Article 151 of that Order (namely):-

Conditions of Landing.

151.—1. The landing of foreign animals at a Landing-Place for foreign animals under the provisions of this Chapter is subject to the following conditions:

First. That the vessel in which they are imported has not, within twenty-eight days before taking them on board, had on board any animal exported or carried coastwise from a port or place in any country other than Her Majesty's Possessions in North America, or New Zealand, or the Channel Islands, or the United States of America (provision as to which country is made by the second con-

dition of this Article), or the Isle of Man. Second. That the vessel in which they are imported has not, within twenty-one days before taking them on board, had on board any animal exported or carried coastwise from a port or place in the United States of America.

Third. That the vessel in which they are imported has not, within twenty-one days before taking them on board, or at any time since taking on board the animals imported, entered any port or place in any country other than Her Majesty's Possessions in North America, or New Zealand, or the Channel Islands, or the United States of America, or the Isle of Man.

Fourth. That the animals imported have not, while on board the vessel, been in contact

with any animal exported or carried coastwise from any port or place in any country other than Her Majesty's Possessions in North America, or New Zealand, or the Channel Islands, or the Isle of Man.

2. And the animals imported shall not be landed at a Landing-Place for foreign animals unless and until-

(a) The owner or charterer of the vessel in which they are imported, or his agent in England or Wales or Scotland, has entered into a bond to Her Majesty the Queen, in a sum not exceeding one thousand pounds, with or without a surety or sureties, to the satisfaction of the Commissioners of Customs, conditioned for the observance of the fore-

going conditions; and (b) The master of the vessel has on each occasion of importation of foreign animals therein satisfied the Commissioners of Customs, or their proper officer, by declaration made and signed or otherwise, that all the animals then imported therein are properly imported according to the provisions of this Article.

Interpretation.

4. In this Order terms have the same meaning as in the Animals Order of 1886.

Short Title.

5. This Order may be cited as THE ANIMALS (AMENDMENT) ORDER OF 1892, No. 4.

Commencement.

6. This Order shall commence and take effect from and immediately after the fourth day of April one thousand eight hundred and ninety-

CIVIL SERVICE COMMISSION, April 1, 1892.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz. :-

Special Regulations (supplementary to the General Regulations issued 8th April 1872, and amended by subsequent notices in the London Gazette) respecting Open Competitive Examinations for the situation of Assistant Surveyor, Royal Engineer Civil Staff.

N.B.—These Regulations are liable to alteration for future Examinations.

I. The limits of age for this situation are 21 and 30, and Candidates must be of the prescribed age on the first day of the competitive Examination. Persons already serving as Temporary Clerk of Works will be eligible in respect of age if their service commenced when they were under 30, if their age does not at the date of the Examination exceed 40, and if their service has been continuous up to same date.

II. Candidates will be required to show what technical education and practical training they have undergone to qualify themselves for a situation of this nature. They must show (1) that they have served, for at least three years, in a public or private office, under an Architect, Builder, Civil Engineer, or Surveyor; (2) that the works on which they have been engaged during those years were such as to afford them the opportunity of gaining a satisfactory knowledge of their profession; and (3) that they have fully profited by their practical training, and possess the necessary qualifications and experience. Evidence on these points must be sent in at such times and in such manner as the Civil Service Commissioners may appoint. If such evidence should prove primâ facie satisfactory, the Candidate will be admitted to Examination, subject, in the case of his being successful in the competition, to such further inquiry, and the production of such further evidence, as may be necessary.

III. The Examination will consist of two parts, and will be in the following subjects, viz. :-

PART I.—PRELIMINARY.

1. Handwriting and Orthography.

2. English Composition, as tested by writing letters from rough notes.

3. Arithmetic (including Vulgar and Decimal Fractions.

(The Examination in subjects 1 and 3 will include tests of rapidity as well as of neatness and accuracy.

* * No Candidate who fails to show satisfactory proficiency in any of the subjects specified above will be admitted to the competitive part of the Examination.

PART II.—COMPETITIVE.

- 1. One of the following (at the option of the Candidate) :-
 - (a) Architectural Drawing.
 - (b) Engineering Drawing.(c) Preparation of Working Drawings for details of Builders' work.
- 2. Theory of Construction.
- 3. Strength and quality of materials, and description of workmanship, tools, and plant.
- Analysis of prices.
- 5. Measurement and estimate of Builders' work, including taking off quantities from Drawings and preparing the Abstracts and Bills of Quantities.
 6. Sanitary Engineering.
- In addition to the above six subjects a Candidate may take up any of the following optional subjects :-
 - A. Euclid (the first three Books).
 - B. Algebra, including quadratic equations.
 - C. Plane Trigonometry.
 - D. Geometrical Drawing and Freehand Sketches in Outline.
 - E. Chemistry and Mineralogy relating to Building Materials.
- IV. A fee of £1 will be required from every Candidate attending the Preliminary Examination, and a further fee of £4 from every Candidate admitted to the Competitive Examination.
- V. Application for permission to attend an Examination must be made at such times and in such manner as the Commissioners may appoint.
 - ** Candidates must be ready to serve at any station at home or abroad.

The Civil Service Commissioners further give notice, that an Open Competitive Examination will be held in London, under the foregoing Regulations, commencing on the 24th May 1892.

A Preliminary Examination will be held in London, Edinburgh, and Dublin, on the 12th May 1892. The number of situations to be filled will be the number vacant at the time of the Examination.

No person will be admitted to the Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 29th April, an application, in the handwriting of the Candidate, on a prescribed form, which may be obtained from the Secretary at once.
