ORDINANCE No. 36.

[ABERDEEN, No. 4.—FOUNDATION OF CHALMERS  
CHAIR OF ENGLISH LITERATURE.]

At Edinburgh, the sixteenth day of October  
Eighteen hundred and ninety-three  
years.

WHEREAS by the Universities (Scotland) Act, 1889, the Commissioners under the said Act are empowered by Section 14, Sub-section 8, to found new Professorships where such course seems desirable, and where there are sufficient means for their endowment or support either from the funds administered by the Commissioners or otherwise, and to determine in what authority the patronage of such Professorships shall be vested.

And whereas by assigment, dated the Twenty-second, and recorded in the Division of the

General Register of Sasines applicable to the County of Aberdeen on the Twenty-fifth, both days of March, Eighteen hundred and ninety-three, the Trustees acting under the General Trust Disposition and Settlement and relative Codicils of the late John Gray Chalmers, sometime residing at Balnacraig, Banchory, have assigned, transferred, and made over to the University of Aberdeen, and the University Court thereof, a Bond and Disposition in security for the sum of Ten Thousand Pounds sterling, granted by Ainslie Douglas Ainslie, Esquire of Delgaty, in the County of Aberdeen, dated the Twenty-third, and recorded in the Division of the General Register of Sasines applicable to the County of Aberdeen on the Twenty-eighth, both days of December, Eighteen hundred and ninety-one: And whereas by Deed of Foundation and Endowment, dated the Third day of April, Eighteen hundred and ninety-three, executed in pursuance of the directions contained in the said testamentary writings, the said Trustees directed and appointed that the said sum should be held by the said University of Aberdeen and the University Court thereof for the purposes, and subject to the conditions and provisions following, *videlicet*:—*In the first place*, That the bequest of the said sum of Ten Thousand Pounds be regarded as a memorial of the long connection of the family, to which the said deceased John Gray Chalmers belonged, with Aberdeen and its University. *In the second place*, That the said capital sum of Ten Thousand Pounds and any accumulations of interest thereon shall be applied and held for the Foundation and Endowment of a Professorship of English Literature in the University of Aberdeen to be called 'The

Chalmers Chair of English Literature in the University of Aberdeen.' *In the third place*, That the Patronage of the said Professorship shall be in the gift and appointment of Her Most Gracious Majesty the Queen and her Royal Successors. *In the fourth place*, That the said University Court shall hold and invest the said sum of Ten Thousand Pounds and any accumulations of interest thereon as a separate fund distinct from the other funds of the University. *In the fifth place*, That the said University Court shall apply the annual income arising from the said sum and from any invested accumulations of interest thereon, along with the fees payable by students for attendance on the lectures or classes conducted by the Professor holding the said Professorship, or such share of a fee fund, should such be instituted by the said University Court or otherwise, as may accrue or be payable to the said Professor, in payment of the salary of the said Professor. *In the sixth place*, That the said Professor shall be bound to teach or lecture in conformity with the provisions for the Department of English contained in the Ordinance No. 11, General No. 6, of the foresaid Commissioners under 'The Universities (Scotland) Act, 1889,' or in any other Ordinances now in force, or which may hereafter be enacted by the foresaid Commissioners, and thereafter according to whatever Ordinances or other Regulations may be in force for the time being in the University of Aberdeen, regarding the Department of English. *In the seventh place*, That, on or before the appointment of the said Professor, arrangements be made for the discontinuance of the Lectures on English Literature at present delivered by the Professor of Logic. *In the eighth place*, That the chief subject of the Professorship shall be the History and Criticism of English Literature, both Prose and Verse, including that portion of it known as Lowland Scotch; but the said Professor shall also be bound to give systematic instruction in (a), the principles of English Style and Composition and Essay Writing, including the principles of Rhetoric; and (b), the Philology of the English Language. *In the ninth place*, That the said Professor shall be bound and obliged, if required by the said University Court, in addition to teaching the class or classes of Art students according to the immediately preceding provision, to give a separate course of a more popular character, and available for students paying a modified entrance fee in place of a matriculation fee; and that, subject to any regulations made, or to be made, by the said University Court, attendance on this latter class be accepted in the case of students studying for a Degree in Law, and not already possessed of an Arts Degree. *In the tenth place*, That, in the event of the recognition of Assistants to Professors as an ordinary part of the University teaching staff, the said Professor shall have an equal claim with other Professors in the Faculty of Arts to the services of an assistant. *In the eleventh place*, That the said Professor shall be entitled to all the privileges, and the full position of a Professor in the University, including right to pension after service, but, at the same time, shall be subject to the whole bye-laws, conditions, and regulations in force for the time being affecting Professors. *In the twelfth place*, That, should changing circumstances require any variation or alteration on the conditions and provisions contained and set forth in the foregoing paragraphs, *in the sixth, eighth, ninth, and*

*eleventh places* respectively, it shall be in the power of the University Court of the University of Aberdeen for the time being to initiate the procedure under the 'Universities (Scotland) Act, 1889,' or any Act amending the same necessary to carry into effect such variations or alterations as they may deem expedient; but before such procedure is initiated, and before such variations or alterations come into operation, or become of any force or effect, they must be submitted to, and approved of in writing by the Trustees foresaid, or the survivors or survivor of them, and after the death of the last survivor must, in like manner, be submitted to, and approved of in writing by, the Chancellor of the University of Aberdeen for the time being.

Therefore the Commissioners under the said Act statute and ordain with reference to the University of Aberdeen as follows:—

I. There shall be a Professorship of English Literature in the University of Aberdeen (to be called the Chalmers Chair of English Literature in the University of Aberdeen), and the Professor shall be a Professor in the Faculty of Arts in the said University.

II. The provisions and conditions contained in the said Deed of Foundation and Endowment, and hereinbefore recited, shall apply to the said Professorship in so far as they are not inconsistent with the provisions of the said Act.

III. Subject always to the said provisions and conditions, there shall be attached to the said Professorship the salary provided by Ordinance No. 26 [Aberdeen No. 2—Regulations as to Application of Parliamentary Grants, as to Salaries, and for the Institution of a Fee Fund, and for other purposes].

IV. The Patronage of the said Professorship, and right of presenting or appointing the Professor shall be vested in, and exercised by, Her Majesty the Queen and her Royal Successors.

V. This Ordinance shall come into force from and after the date on which it is approved by Her Majesty in Council.

## ORDINANCE No. 37.

[ABERDEEN, No. 5.—REGULATIONS AS TO THE DUTIES OF THE PROFESSOR OF LOGIC.]

At Edinburgh, the sixteenth day of October  
Eighteen hundred and ninety-three  
years.

WHEREAS by the Universities (Scotland) Act, 1889, the Commissioners under the said Act are empowered by Section 14, Sub-section 2, to regulate the duties of Professors; and by the said Section 14, Sub-section 16, to repeal or modify any Ordinance made under the provisions of the Universities (Scotland) Act, 1858.

Therefore the Commissioners under the first-mentioned Act statute and ordain, with reference to the University of Aberdeen, as follows:—

I. The Professor of Logic shall in future lecture on Logic and Metaphysics, and shall not be required to lecture on English Literature.

II. Ordinance No. 12 of the Commissioners under the Universities (Scotland) Act, 1858, in so far as it is inconsistent with the provisions of the preceding Section hereof, is hereby repealed.

III. This Ordinance shall come into force from and after the date on which it is approved by Her Majesty in Council.

## ORDINANCE No. 38.

[ABERDEEN, No. 6.—REGULATIONS AS TO UNIVERSITY MEETINGS.]

At Edinburgh, the sixteenth day of October  
Eighteen hundred and ninety-three  
years.

WHEREAS by the Universities (Scotland) Act, 1889, hereinafter referred to as the first-mentioned

Act, the Commissioners under the said Act are empowered by Section 14, Sub-section 5, to regulate the management and ordering of the Universities, and by the said Section, Sub-section 16, to repeal or modify any Ordinance made under the provisions of the Universities (Scotland) Act, 1858.

And whereas by Ordinance No. 6, Aberdeen No. 2, of the Commissioners under the said Universities (Scotland) Act, 1858, it is provided that Meetings of the Senatus Academicus of the University of Aberdeen, and Meetings for Graduation in the Faculties of Arts and Divinity, shall be held in that portion of the University Buildings hitherto belonging to and occupied by King's College; and that Meetings for other Graduation, and Meetings of the General Council and of the University Court, and also Meetings for the Election of Rector and for public installations, shall be held in that portion of the University Buildings hitherto belonging to and occupied by Marischal College.

Therefore the Commissioners under the first-mentioned Act statute and ordain, with reference to the University of Aberdeen, as follows:—

I. (1) The Senatus Academicus shall have power to hold its Meetings in any of the University Buildings, as the Senatus may from time to time determine.

(2) Meetings for Graduation in any Faculty, or for public installations, may be held in any of the University Buildings, or elsewhere, as the Senatus may from time to time determine.

(3) The University Court shall have power to hold its Meetings in any of the University Buildings, as the Court may from time to time determine.

II. Ordinance No. 6, Aberdeen No. 2, of the Commissioners under the Universities (Scotland) Act, 1858, in so far as it is inconsistent with the provisions of this Ordinance, is hereby repealed.

III. This Ordinance shall come into force from and after the date on which it is approved by Her Majesty in Council.

(Dissolution of the Falkirk Joint Stock Gas Company, Limited; Incorporation of New Company; Declaration and Arrangement of Capital; Borrowing Powers; Vesting in New Company of Undertaking of Existing Company; Power to Supply Gas; Limits of Supply; Maintenance of Existing and Construction of New and Additional Gasworks, and Manufacture and Storage of Gas, Residual Products, &c., on Lands Described; Acquisition of Lands by Agreement or Compulsion; Sale, &c., of Superfluous Lands; Maintenance, Extension, &c., of Existing Mains, &c.; Breaking up of Streets, &c., for Mains, &c.; Powers to Sell Gas in Bulk, to deal in Residuals, &c., to Acquire Patent Rights, to Manufacture, Sell, Hire, &c., Gas Meters and Fittings; Agreements with Local Authorities and Others; Rates, Rents, and Charges for Gas, &c.; Incorporation and Amendment of Acts; and other Purposes).

NOTICE is hereby given, that the Falkirk Joint Stock Gas Company, Limited (hereinafter called 'the Limited Company') intend to apply to Parliament in the ensuing Session for leave to bring in a Bill for all or some of the following among other purposes, that is to say:—

1. To dissolve the Limited Company and to cancel and annul their deed of copartnership and resolutions under the Joint Stock Companies' Act 1856 and the Companies' Acts 1862 and 1867, and to provide for their winding up and re-incorporation as a new Company (hereinafter called 'the Company'), including the shareholders of the Limited Company, or some of them, with or without other persons or corporations, by the name of the Falkirk and District Gas Company, or by some other name, and to confer on the Company all necessary powers and authorities for carrying into effect the objects of the Bill.

To empower the Company to supply gas for domestic, trading, public, and other purposes in the Burgh of Falkirk as defined for municipal purposes by the Falkirk Corporation Act, 1890, and also parts of the parishes of Falkirk, Larbert, and Bothkennar, all in the county of Stirling, and contained within the following boundaries, that is to say, commencing at the point on the municipal boundary of the Burgh of Falkirk where the road

to the Railway (High) Station at Falkirk branches off from the road leading from Falkirk to Slamannan, thence southwards to the point where the road known as the Slamannan West Road diverges to Slamannan and south-westwards along the said Slamannan West Road to the bridge by which that road is carried over the Edinburgh and Glasgow Railway, thence westward along the north side of that railway to the west side of the bridge crossing that railway near the railway siding of the Lime Wharf Chemical Works, thence westward and northward along the south and west side of the road leading from the said last mentioned bridge to the Forth and Clyde Canal, thence north-westward in a straight line to the point where the road to Larbert Grinding Mill diverges from the public road from Larbert to Dunipace Bridge, thence northward to the point on the public road from Larbert to Stirling, where the entrance to Glenberrie branches off that road, then in a straight line north-eastward to the point on the road leading from Carron to Dunmore where the road to Hill of Kinnaird Farm Steading diverges from that road, thence south-eastward to the point on the south side of the road from Carronshore to Bothkennar Church, one hundred yards eastward of its junction with the road from Carronshore to Kinnaird, thence in a straight line southwards to the north-east corner of the municipal boundary of the burgh of Falkirk, thence following said burgh boundary southward and south-westward to the point of commencement, hereinafter referred to as 'the limits of supply.'

5. To authorise the Company to maintain and continue the existing gasworks of the Limited Company on the lands firstly hereinafter described, and to alter, enlarge, improve, renew or discontinue those works, and upon such lands and also on the lands secondly hereinafter described to construct and maintain, alter, enlarge, improve, and renew or discontinue additional gasworks and works, for the conversion, manufacture, utilisation, and distribution of materials used in and about the manufacture of gas, and of residual and manufactured products, matters, and things, and to manufacture, produce, store, supply, and sell gas, and manufacture, store, convert, utilise, buy, sell, and dispose of coke, coal, patent fuels, coal-tar, pitch, asphaltum, ammoniacal liquor, oil, and all other residual and manufactured products, matters, and things.

6. The lands to be so held and used by the Company for the manufacture and storage of gas and for gasworks, and for the manufacture and storage of residual products and the other purposes of their Undertaking, are—

First.—The lands on which, or on parts of which the existing gasworks and gas holders of the Limited Company are erected, that is to say:—

- (1) A piece of land situate at Bainsford Bridge within the Burgh of Falkirk, containing two thousand and fifty-one square yards or thereabouts, bounded on the east by Graham's Road, on the north and west by the Forth and Clyde Canal, and on the south by Canal Street.
- (2) A piece of land within the Burgh of Falkirk, containing one thousand nine hundred and fifty square yards or thereabouts, bounded on the north by Canal Street, on the east by Simpson Lane,



on the south by John Street, and on west by the Forth and Clyde Canal and a loading basin connected therewith

- (5) A piece of land situate at Firs within the Burgh and Parish of Falkirk containing seven acres thirty-two poles belonging, or reputed to belong, to the North British Railway Company bounded on the north in the first place by the gardens attached to the dwelling houses erected on the south side of Wallace Street, belonging, or reputed to belong to Andrew Palmer, James Smith, Thomas Burns, Alexander Hamilton, William Graham, William Johnston, Robert Mallice, William Rae, William Lyon, George Bisset, William Morrison, Robert Davidson, William Strang, John M'Lachlan, and James Sutherland; then, on the east, by the back ground of tenement dwelling houses erected on the west side of Thornhill Road, belonging or reputed to belong to David Taylor, and again on the north by the ground attached to said tenement dwelling houses; again, on the east, by Thornhill Road; on the south, in the first place, by the lands and buildings of the Falkirk Cottage Hospital; then, on the west, by lands belonging, or reputed to belong, to William Forbes of Callendar; and again, on the south, by the said William Forbes' lands; and again, on the west, by other lands of the Estate of Firs, belonging, or reputed to belong, to the North British Railway Company, and occupied by the Callendar Coal Company as a brickwork.

To empower the Company to purchase and acquire by agreement or compulsion, for the purposes of their undertaking, the lands and other property secondly hereinbefore described, and to purchase or take on lease or otherwise acquire by agreement, and to hold other lands, houses, and hereditaments for purposes other than the manufacture or storage of gas within the limits of supply, or to acquire easements or rights

over or under any such lands and hereditaments, and to sell, feu, lease, or otherwise dispose of any lands, works, and property from time to time vested in or purchased by the Company, or to exchange any such land.

8. To authorise the Company to acquire and hold patent rights and licenses in relation to the manufacture or distribution of gas and the utilisation of the residual products obtainable therefrom, or the production by any means of artificial light; to deal in, sell, and dispose of coal, lime, coke, patent fuel, coal-tar, pitch, asphaltum, ammoniacal liquor, oil, chemicals, and other residual and manufactured products, and other matters and things, and to carry on the business usually carried on by gas companies; to manufacture, purchase, or hire, and supply gas meters, fittings, gas stoves, and cooking or other apparatus, and also to manufacture, purchase, let, or deal in and contract for doing work in connection with fittings, tubes, meters, pipes, apparatus, stoves, ranges, and apparatus for heating, and also engines and machines for the production of motive power for domestic, agricultural, manufacturing, and other purposes by means of gas, and all articles and things in any way connected with gas-works or with the supply of gas.

9. To authorise the Company to maintain, alter, or renew any existing works, mains, and pipes within the limits of supply, and within those limits to make such extensions of the mains, pipes, and works of the Limited Company as may in the opinion of the Company be necessary, and for that purpose to open and break up, or interfere with railways, streets, roads, highways, footways, sewers, drains, pipes, electric telegraphing and telephonic apparatus, rivers, canals, bridges, passages, or other places within the limits of supply.

10. To authorise the Company to supply gas in bulk to any local authority, authorised to supply gas or to any Gas Company or person for resale and distribution in any adjoining districts beyond the limits of supply and to enter into and fulfil contracts and agreements for the supply of gas within or without the limits of supply with any County Council or other local authority, Corporation, Companies, bodies or persons, to vary, suspend, or rescind any such contracts or agreements, and to enter into and carry into effect other agreements and contracts in lieu thereof or in addition thereto, and to authorise any such County Council or other body or person as aforesaid respectively to apply their respective funds and to raise further monies for the purposes of any such contract or agreement.

11. To authorise the Company to levy and recover rates, rents and charges, for the supply of gas and residual products, for the supply, hire, or use of meters, fittings, engines, and other articles and things supplied, and for work done by the Company, and to recover rates, rents and charges, due and owing to the Limited Company at the date of its re-incorporation into the Company; to alter existing rates, rents and charges, and to confer, vary or extinguish exemptions from the payment of rates, rents and charges.

12. To vary or extinguish all, or any rights and privileges, which would interfere with the purposes of the Bill, and to confer other rights and privileges, and generally to confer all such further and other powers as may be deemed necessary or expedient for effecting the purposes aforesaid or any of them.

13. To incorporate with the Bill and extend



and apply as well to the mains, pipes, and works of the Limited Company, laid down or constructed before the passing of the Bill as to all mains, pipes and works which may be laid down or constructed under the authority of the Bill after it has become a law, the powers and provisions of the Gas Works Clauses Act, 1847, and the Gas Works Clauses Act, 1871, except so far as the same may be expressly varied by the Bill, and also to incorporate all or some of the provisions of the Lands Clauses Acts, the Companies Clauses Consolidation (Scotland) Act, 1845, and the Companies Clauses Act, 1863, as amended by the Companies Clauses Act, 1869, and so far as may be necessary or expedient to alter, amend, repeal, or extend all or some of the provisions of those Acts or any of them.

14. To empower the Local Authority to appropriate, for the purposes of the proposed undertaking, any lands belonging to or held by them, and to purchase, take in feu, or on lease, or otherwise acquire by agreement, lands, houses, and hereditaments, or easements, servitudes, or rights in or over the same, and to sell, lease, or dispose of any lands, houses, or hereditaments so acquired by them, and to erect, maintain, work, and use upon such lands all necessary Stations, Storehouses, Engines, Machinery, Apparatus, Works, and Appliances for the production, storage, and distribution of Electricity.

To empower the Local Authority to manufacture, purchase, hire, sell, supply, let, and deal in all Machines, Lamps, Accumulators, Meters, Fittings, Plant, Machinery, and other Apparatus required for the purposes of production, storage, utilisation, supply, or measurement of Electricity.

To authorise the Local Authority to make charges and levy rates for the supply of Electricity, and for the use of any Machines, Lamps, Accumulators, Meters, Fittings, or Apparatus connected therewith, and to recover such rates and charges.

To make provision for the inspection and testing of Mains, Conductors, Meters, and Works, for the appointment and remuneration of Electric Inspectors, and for the supply, use, and inspection, testing, and certifying of Meters, Fittings, and Instruments.

To empower the Local Authority to transfer to any other Local Authority, Company, or Person, all or any of the powers, duties, or liabilities given to or imposed upon them by the said Order or the said Electric Lighting Acts.

To incorporate with the said Order, and to extend and apply to the proposed undertaking and works, and to the Local Authority as undertakers, with or without alteration, all or some of the provisions of the said Electric Lighting Acts, 1882 and 1888, and of the Acts or portions of Acts incorporated therewith; and to confer upon the Local Authority all or some of the powers

within the area of supply which by the said Acts, or any Acts amending the same, or incorporated therewith, are or may be conferred upon undertakers; and the Order will contain all such regulations and conditions as to the supply of electricity, and all matters incidental thereto, and the obligations of the Local Authority in relation thereto, as are authorised by the said Acts, or as the Board of Trade may prescribe, and will confer on the Local Authority all powers, rights, and privileges necessary or expedient for carrying out the purposes of the said Order, and will vary or extinguish all rights and privileges which may be inconsistent therewith.

Subject to the conditions of supply, it is proposed to lay down Electric Lines in the following streets, or parts thereof, within a period to be specified in the Order, viz.:—Low-waters, Portland Place, Gateside Street, Quarry Street, Townhead Street, Miller Street, Duke Street, Brandon Street, Union Street, Burnbank Road, Almada Street, Muir Street from Bothwell Road to Cadzow Street, Cadzow Street.

The following are the streets and places not repairable by the Local Authority, which the Local Authority propose to take power to break up, viz.:—Strathmore Road, Barncluith Road, Road in front of Castlehill Crescent, Selkirk Street, Burnblea Street, Butterburn Park Street, Scott Street, School Street, Hall Street, Field Street, Tuphall Road from end of houses opposite Corporation Stables to junction with South Park Road, South Park Road, Dixon Street, Burn Street, Glebe Street, Bothwell Street, Whitehill Road where widened by feuars, Ann Street, Windsor Street, Gladstone Street, Watson Street, Holyrood Street, Burnbank, Greenfield Road, Road from Greenfield Colliery gate to Old and New Greenfield Rows, Bertram Street, Glenlee Street, John Street, Greenfield Street, Road leading from High Blantyre Road to Earnock Colliery, Road at Albert Buildings.
