(Extension of Objects and Business; Power to Declare and Pay Interim Bonus; Repeal or Amendment of Deed of Settlement and Acts.)

LOCH EFORT HARBOUR AND PIER.

(PROVISIONAL ORDER.)

(Construction of New Pier and Road—Maintenance of Existing Pier—Constitution of Undertakers as Harbour and Pilotage Authority—Power to Levy Tolls, &c.—To Dredge—To Regulate Harbour, &c.—Make Bye-Laws and Borrow Money—And for Other Purposes.)

NOTICE is hereby given, that, on or before the 23rd day of December next, application will be made to the Board of Trade by or on behalf of Sir John William Powlett Campbell Orde of Kilmory, Baronet (who and whose assigns are hereinafter referred to as 'the Undertakers'), pursuant to the General Pier and Harbour Act, 1861, and the General Pier and Harbour Act, 1861, Amendment Act, for a Provisional Order for effecting all or some of the following purposes:—

1. To authorise the construction at Loch Efort (otherwise Eford or Eport), in the Island of North Uist, in the Parish of North Uist, and County of Inverness, of the Pier and Road hereinafter described, or some part or parts thereof respectively, with all works and conveniences connected therewith, that is to say—

2. To constitute the Undertakers the Harbour and Pilotage Authority at Loch Efort, and to define the limits of the Harbour, and within which the Undertakers shall have authority.
