Board of Trade—Sesson 1894. STIRLING ELECTRIC LIGHTING.

(Power to the Caledonian Electric Supply Company (Limited), to Generate, Store, and Supply Electricity for Public and Private Purposes within the Area included in the Municipal Boundaries of the Royal Burgh of Stirling; to Construct Works; to Lay Down Wires and Other Apparatus; to Break Up, or Interfere With, Streets, Railways, and Tramways therein; to Acquire and Appropriate Land; to Levy Rates; to Make Contracts and Transfers of Undertaking and to Exercise Other Powers; Incorporation and Amendment of Acts.)

OTICE is hereby given, that the Caledonian Electric Supply Company (Limited) (hereinafter called 'The Undertakers'), and whose registered address is No. 57 Queen Street, Edinburgh, intend to apply to the Board of Trade for a Provisional Order (hereinafter called 'The Order'), to be confirmed by Parliament in the ensuing Session, under and subject to the provisions of the Electric Lighting Acts, 1882 and 1888, and the Electric Lighting (Scotland) Act, 1800.

The objects of the application are as follows:-

1. To authorise the Undertakers to Generate, Store, and Supply Electricity as defined by the said Acts, for Public and Private purposes, within the area of supply as hereinafter defined; and for those purposes to open, break up and interfere with, all streets, roads, and public places, ways, hs, railways, tramways, towing-paths, bridges, canals, footpaths, bridges, culverts, sewers, drains, gas and water mains and pipes, and telegraph and pneumatic tubes and pipes, and telegraph and telephone wires within the said area; and to lay down, set up, maintain, renew, alter, and remove, either above or under ground, or otherwise, pipes, tubes, wires, posts, distributing boxes, apparatus and other works or things required for the purpose of enabling the Undertakers to generate, supply, store, transmit, and distribute Electricity for Public and Private purposes within the said area; and to confer all such other powers upon the Undertakers as may be necessary for effecting the objects of the proposed undertaking; including the power to transfer the rights to be granted in pursuance hereof to any Local Authority, Person or Persons, Company or Companies, in such manner and upon such terms as the Board of Trade may from time to time approve.

2. To enable the Undertakers to purchase, hold, acquire, feu, or take on lease any lands or interests, or easements, and servitudes or rights in or over any lands, or to appropriate for the purposes of the Order any lands belonging to or held by them, or to sell, lease, sublet or dispose of any lands, houses, or hereditaments; and to erect, maintain, work, and use upon such lands all necessary stations, store-houses, engines, dynamos, machinery, apparatus, works and appliances for the generation, storage, and distribution of Electricity,

and incidental thereto.

3. To authorise the Undertakers to manufacture, purchase, hire, sell, and let all necessary plant, machinery, lamps, accumulators, meters, fittings, and other apparatus or things required for the purposes of the Order; and to acquire, work, and use patents for the generating, storing, controlling, and measuring or otherwise relating to the supply of Electricity.

4. To authorise the Undertakers to take, collect, and recover rates, rents, and charges for the supply of electricity, and the use of any machines, accumulators, lamps, meters, fittings or apparatus connected therewith.

5. To authorise the Undertakers to enter into Contracts and Agreements with any Local or other Public Authority, Corporation, Public Gas Commissioners, Company or persons for the transfer of the powers, duties, liabilities, and works of the Undertakers, or any part of the same, and for the execution and maintenance of all or some portion or portions of the works, and the generation, storage, and supply of electricity within the whole, or any part or parts of the area of supply, and to relieve the Undertakers from the consequences of any acts or defaults of any such contractors; and to authorise and enable all or any such contractors to enter into and carry into effect any such Contracts and Agreements, and to apply their funds and revenues and property for all or any of the

purposes of such Contracts and Agree-

ments and this Order.

6.
