OFFICE OF THE SECRETARY FOR SCOTLAND, WHITEHALL, December 1, 1893.

THE Queen has been pleased to direct Letters Patent to be passed under the Seal appointed to be made use of in place of the Great Seal of Scotland, nominating and appointing James Bell, Esquire, Lord Provost of the City of Glasgow, to be Her Majesty's Lieutenant of and in the County of the City of Glasgow.

Her Majesty has also been pleased to direct the issue of a separate Commission of the Peace for the said County of the City of Glasgow.

The Queen has further been pleased to direct Letters Patent to be passed under the Great Seal of the United Kingdom, granting a Court of Quarter Sessions of the Peace to the said County of the City of Glasgow.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation stating that he has received a copy of an Interlocutor by the Sheriff-Substitute of Stirling, Dumbarton, and Clackmannan, at Falkirk, finding

that the existing or Old Churchyard of Muiravon side is offensive and contrary to decency:

And whereas in the said Representation it is recommended that burials be discontinued in the said Old Churchyard or burial ground except in the private enclosed spaces of Mr. William Stirling, of Tarduf, Mr. Thomas Livingstone-Learmouth, of Parkhall and Craigend (for Parkhall), the said Mr. Thomas Livingstone-Learmouth, of Parkhall and Craigend (for Craigend), the Pearsons, of Vellore, Mr. James Russel, of Blackbraes, and the private burial ground of Mr. Matthew Malcolm Henderson, at present unenclosed, but which is to be enclosed, and in the space of ground of Mr. Andrew Reid, of Haining Valley, the space of ground of Mr. Andrew Bryce, of Blackston, for himself and his spouse, the space of ground of Miss Mary Binnie and Miss Jane Binnie, late of Avonbank, for themselves, and except for the burial of any person whose husband or wife shall have been interred in said burial ground previous to the date of this Order:

Provided, as regards all future interments, that the exercise of the said right shall not be injurious to the public health; that no graves be less than five feet deep; and that no grave be buried in unless it can be opened to that depth without the exposure of the coffins; and that notice be given to the Sanitary Inspector on the day preceding that on which a grave is to be opened; provided also, that the permission to inter is revocable at any time.

Now, therefore, Her Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of Her Majesty's Most Honour-

able Privy Council on the eighth day of January Consolidated Tables of Light Duties, sanctioned by an Order in Council dated the twenty-fourth

And Her Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order or notice thereof, be affixed, as required by the above-mentioned Act, on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such Representation one month before such Representation is so considered.

Whereas by the four hundred and tenth section of 'The Merchant Shipping Act, 1854,' it is enacted that, upon the completion of any new Lighthouse, Buoy, or Beacon, Her Majesty may, by Order in Council, fix such dues in respect thereof, to be paid by the Master or Owner of every ship which passes the same, or derives benefit therefrom, as Her Majesty may deem reasonable, and may from time to time alter the amount thereof; and that such dues shall be paid and collected in the same manner, by the same means, and subject to the same conditions, in, by, and subject to which the Light Dues authorised to be levied by the said Act are paid and collected:

And whereas the Commissioners of Northern Lighthouses have established or are about to establish a Lighthouse on Hellyar Holm:

And whereas it is fit and proper that in respect of the said Lighthouse dues should be levied as hereinafter mentioned:

Now, therefore, Her Majesty, in exercise of the powers vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct that, from and after the date of the exhibition of the said Light, or from and after the time of the receipt of notice of the present Order, if that be later, by the officers authorised to collect Light Dues, the following rates shall be paid, that is to say:—

(a) On all vessels whether British or Foreign which may pass or derive benefit from the said Light, that is to say, on all vessels which shall pay toll for Auskerry Light, twosixteenths of a penny per ton of the burden of every such ship if on an oversea voyage, and one-sixteenth of a penny per ton if on a coasting voyage, for each time of passing or deriving benefit.

(b) On all vessels whether British or Foreign entering or leaving Kirkwall Harbour or its approaches if of or under fifty tons burden sixpence, and for every additional fifty tons burden or part of fifty tons burden sixpence.

Provided that any vessel which may have paid the harbour toll marked (b) shall not be also liable to the general passing toll marked (a) in respect of the same voyage.

The said tolls shall be levied subject to the regulations and exemptions contained in the

Consolidated Tables of Light Duties, sanctioned by an Order in Council dated the twenty-fourth day of November one thousand eight hundred and ninety-one, or to such other regulations and exemptions as may from time to time be duly sanctioned, and subject also to the gross abatement or discount of sixty-five per centum, mentioned in the said Order in Council, dated the twenty-fourth day of November one thousand eight hundred and ninety-one, or to such other abatement or discount as may for the time being be in force.

Now, therefore, Her Majesty, in exercise of the powers vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct that, from and after the exhibition of the said Light, or from and after the time of the receipt of notice of such exhibition by the officers authorised to collect Light Dues, there shall be paid in respect of the said Light for every ship, whether British or Foreign, navigating within five miles of Heston Island Light, the toll of eight-sixteenths of a penny per ton of the burden of every such ship for each time of passing or deriving benefit therefrom if on an oversea voyage, and one-sixteenth of a penny per ton if on a coasting voyage.

The said tolls shall be levied subject to the regulations and exemptions contained in the Consolidated Tables of Light Duties sanctioned by Order in Council dated the twenty-fourth day of November one thousand eight hundred and ninty-one, or to such other regulations and exemptions as may from time to time be duly sanctioned, and subject also to the gross abatement or discount of sixty-five per centum mentioned in an Order in Council dated the third day of May one thousand eight hundred and eighty-eight, or to such other abatement or discount as may for the time being be in force.

'The Colonial Probates Act, 1892,' shall apply to the British Possession hereunder mentioned:—

The Bahama Islands.

And the Most Honourable the Marquess of Ripon, Her Majesty's Principal Secretary of State for the Colonies, is to give the necessary directions herein accordingly.
