(Additional Tramways to be included in the Bill for which application has been made to Parliament; Application of Glasgow Corporation Tramway Acts; Gauge; Motive Power; Deposit of Plans, Sections, &c.)

Provost, Magistrates, and Council of the Provost, Magistrates, and Council of the City and Royal Burgh of Glasgow (hereinafter called the Corporation), who are promoting in the ensuing Session of Parliament a Bill (hereinafter referred to as "the Bill") under the above name or short title, intend to make application to Parliament in the ensuing Session, by Petition, for additional provision to enable them to make and maintain, in addition to the works described in the Bill, the short junction Tramways hereinafter described, with all the necessary works and conveniences connected therewith, that is to sav—

A Tramway No. 1, wholly double line, situate in the Parish of Govan, commencing by a junction with the existing Tramways in Paisley Road at a point opposite the centre line of Crookston Street at its junction with Paisley Road, and thence proceeding in an easterly direction along Paisley Road and King Street (Tradeston) to Bridge Street, and thence proceeding in a northerly direction into and terminating in Bridge Street by a junction with the existing Tramways at a point opposite or nearly opposite the entrance door of the premises No. 25 Bridge Street.
