The QUEEN's Most Excellent Majesty in Council.

W HEREAS by the four hundred and tenth section of 'The Merchant Shipping Act, 1854,' it is enacted that, upon the completion of any new Lighthouse, Buoy, or Beacon, Her Majesty may, by Order in Council, fix such dues in respect thereof, to be paid by the Master or Owner of every ship which passes the same, or derives benefit therefrom, as Her Majesty may deem reasonable, and may from time to time alter the amount thereof; and that such dues shall be paid and collected in the same manner, by the same means, and subject to the same conditions, in, by, and subject to which the Light Dues authorised to be levied by the said Act are paid and collected :

And whereas by the said Act 'buoys and beacons' include all other marks and signs of the sea:

And whereas the Commissioners of Northern Lighthouses have established in the Firth of Forth the following lighted buoys and beacon, viz. :--

Beamer Beacon,
North Craig Buoy,
Herwit Rock Buoy,Drum Sands West Buoy,
Dodd's Bank Buoy,
Hen and Chickens Buoy.

And whereas it is fit and proper that in respect of the said buoys and beacon dues should be levied as hereinafter mentioned :

Now, therefore, Her Majesty, in exercise of the powers vested in Her by the said recited Act, by and with the advice of Her Privy Council, is pleased to direct that, from and after the date of the present Order, or from and after the time of the receipt of notice of the present Order by the officers authorised to collect Light Dues, the following rates shall be paid on all vessels for each time of entering or leaving the Firth of Forth by crossing an imaginary line from Elie Ness to North Berwick, and on all vessels navigating to or from any port or place within the afore-mentioned imaginary line; that is to say, three pence for every 50 tons burden or part of 50 tons burden of such vessel; but vessels liable for the first toll, viz., that for crossing the imaginary line specified, are not chargeable with the second toll when calling at intermediate ports if on the same voyage.

The said tolls shall be levied subject to the regulations and exemptions contained in the Consolidated Tables of Light Duties sanctioned by an Order in Council, dated the 24th day of November 1891, or to such other regulations and exemptions as may from time to time be duly sanctioned, and subject also to the gross abatement or discount of sixty-five per centum mentioned in the said Order in Council, dated the 24th day of November 1891, or to such other abatement or discount as may for the time being be in force.

WHEREAS by the 'Burial Grounds (Scotland) Act, 1855,' as amended by 'The Secretary for Scotland Act, 1885,' it is enacted that it shall be lawful for Her Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland, that a copy of an Interlocutor of a Sheriff of a County of Scotland under certain provisions of the said Act has been received, in pursuance thereof, to order that no new burial ground shall be opened within certain limits specified in such order, save with the previous approval of the Secretary for Scotland (or as the case may require) that after a time mentioned in such order burials within certain limits, or in certain burial grounds or places of burial shall be discontinued wholly or subject to any exceptions or qualifications mentioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said Act: Provided always, that notice of such Representation, and of the time it shall please Her Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground is situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the church of, or on some other conspicuous places within, the parishes affected by such Representation, one month before such Representation is so considered:

And whereas the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation stating that he has received a copy of an Interlocutor by the Sheriff-Substitute of Stirling, Dumbarton, and Clackmannan, at Falkirk, finding that the existing or Old Churchyard of Muiravonside is offensive and contrary to decency :

And whereas in the said Representation it is recommended that burials be discontinued in the said Old Churchyard or Burial Ground, except for the burial of certain persons on the conditions hereinafter named :

And whereas notice of the said Representation and of the time when it pleased Her Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council has been duly published in the Edinburgh Gazette and has been fixed as required by the said Act :

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order as follows, viz. :-

That burials be discontinued in the said Old Churchyard or burial ground except in the private enclosed spaces of Mr. William Stirling, of Tarduf, Mr. Thomas Living-stone-Learmouth, of Parkhall and Craigend (for Parkhall), the said Mr. Thomas Livingstone-Learmouth, of Parkhall and Craigend (for Craigend), the Pearsons, of Vellore, Mr. James Russel, of Blackbraes, and the private burial ground of Mr. Matthew Malcolm Henderson, at present unenclosed, but which is to be enclosed, elsewhere during the period of the holding of

and in the space of ground of Mr. Andrew Reid, of Haining Valley, the space of ground of Mr. Andrew Bryce, of Blackston, for himself and his spouse, the space of ground of Miss Mary Binnie and Miss Jane Binnie, late of Avonbank, for themselves, the space of ground of Mrs. Horn, Loan of Muiravonside, for herself, the space of ground of Mrs. Charlotte Taylor, Loan of Muiravonside, for herself, and except for the burial of any person whose husband or wife shall have been interred in said burial ground previous to the date of this Order : Provided, as regards all future interments, that the exercise of the said right shall not be injurious to the public health; that no graves be less than five feet deep; and that no grave be buried in unless it can be opened to that depth without the exposure of the coffins; and that notice be given to the Sanitary Inspector on the day preceding that on which a grave is to be opened; provided also, that the permission to inter is revocable at any time.

WHEREAS 'The Patents, Designs, and Trade Marks Act, 1883,' amongst other things, provides, by section thirty-nine, that the exhibition of an invention at an Industrial or International Exhibition, certified as such by the Board of Trade, or the publication of any description of the invention during the period of the holding of the exhibition, or the use of the invention for the purpose of the exhibition in the place where the exhibition is held, or the use of the invention during the period of the holding of the exhibition by any person elsewhere, without the privity or consent of the inventor, shall not prejudice the right of the inventor or his legal personal representative to apply for and obtain provisional protection and a patent in respect of the invention or the validity of any patent granted on the application, provided that both the following conditions are complied with, namely :-

- (a) The exhibitor must, before exhibiting the invention, give the Comptroller the prescribed notice of his intention to do so; and
- (b) The application for a patent must be made before or within six months from the date of the opening of the exhibition.

And whereas the said Act further provides by section fifty-seven, that the exhibition at an Industrial or International Exhibition, certified as such by the Board of Trade, or the exhibition

the exhibition, without the privity or consent of the proprietor of a design, or of any article to which a design is applied, or the publication, during the holding of any such exhibition, of a description of a design, shall not prevent the design from being registered, or invalidate the registration thereof, provided that both the following conditions are complied with, namely :--

- (a) The exhibitor must, before exhibiting the design or article, or publishing a description of the design, give the Comptroller the prescribed notice of his intention to do so; and
- (b) The application for registration must be made before or within six months from the date of the opening of the exhibition.

And whereas Her Majesty, by virtue of the authority committed to Her by the provisions of the Patents Act, 1886, is empowered by Order in Council from time to time to declare that the provisions of the said Act of 1883 above recited shall apply to any exhibition mentioned in the Order in like manner as if it were an Industrial or International Exhibition certified by the Board of Trade, and to provide that the exhibitor shall be relieved from the conditions specified in the said hereinbefore recited sections of the said Act of 1883:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and by virtue of the authority committed to Her by the said Act of 1886, doth declare, and it is hereby declared, that the provisions of the foregoing sections of the said Act of 1883 shall apply to the International Exhibition to be held at Vienna in the year one thousand eight hundred and ninety-four; and further, that the exhibitor of an invention, a design, or any article to which a design is applied, shall be relieved from the conditions specified in the said hereinbefore recited sections of the said Act of 1883 of giving notice as therein required of his intention to exhibit such invention, design, or article to which a design is applied.

REGULATIONS respecting Open Competitive Examinations for the situation of Male Sorter in London, in the Department of the Postmaster-General.

These Regulations are liable to alteration for future Examinations.

1. Candidates will be required to satisfy the Civil Service Commissioners :---

(a) That their age on the day of the Examination is not less than 18 nor more than 21.

Note.—In reckoning age for competition, persons who have served for two full consecutive years in the Army or Navy, or in any civil situation to which they were admitted with the certificate of the Civil Service Commissioners, or as Registered Copyists in connection with the Civil Service, may deduct from their actual age any time not exceeding five years which they may have spent in such service.

(b) That they are duly qualified in respect of health and character.

NOTE.—No Candidate will be eligible for appointment who is less than 5 ft. 4 in. in height, or who fails to satisfy the Medical Officers of the Post Office that he is free from any physical defect, disease, or weakness which would be likely to interfere with the proper discharge of his duties, or with his regular and continuous attendance.

Re-vaccination will be required before appointment unless the Candidate exhibit good marks of primary and secondary vaccination, or good marks of vaccination with definite evidence of having had smallpox.

 \cdot 2. At each Examination the number of Candidates to be selected will be such as the Postmaster-General may from time to time fix.

3. The Examination will be in the following subjects, viz. :---

- 1. Handwriting.
- 2. Orthography.
- 3. English Composition, to be tested by a short essay or letter on a simple subject.

4. Arithmetic (first four rules, simple and compound).

5. Geography (general).

Candidates failing in any of the above-named subjects will not be eligible.

4. Persons holding situations in the Civil Service, Engineer Students in the Navy, and Apprentices in Her Majesty's Dockyards, will not be eligible unless they produce to the Civil Service Commissioners the written permission of the authorities of their department to attend the Examination, dated before the commencement of the competition.

5. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

6. A fee of 2s. 6d. will be required from every Candidate attending the Examination.
