#### LOCAL AUTHORITIES LOANS (SCOTLAND) ACTS, 1891 and 1893.

(54 and 55 Vic. cap. 34 and 56 Vic. cap. 8.) Order of the Secretary for Scotland confirming Resolutions of the Town Council of Inverness for the Creation of Redeemable Stock.

W HEREAS it is provided by the Local Authorities Loans (Scotland) Act, 1891, section 6, that a resolution of a Local Authority, as in section 5 of the said Act, shall not take effect unless and until—

(r) It is confirmed at a subsequent meeting of the Local Authority, held after the resolution has been published in the prescribed manner, and after the expiration of the prescribed time, being not earlier than fourteen days after the first publication of such resolution; and (2) It is confirmed by the Secretary for Scotland by an Order under his hand and seal of office:

And whereas the Town Council of the Royal Burgh of Inverness are the Local Authority in the said burgh for the purposes of the Local Authorities Loans (Scotland) Acts, 1891 and 1893:

And whereas the resolutions contained in the schedule appended to this Order were adopted by the Town Council of Inverness at a meeting held on the 23rd day of March 1894, and were confirmed by the said Town Council at a subsequent meeting held after the resolutions had been published in the prescribed manner, and after the expiration of the prescribed time, on the 9th day of April 1894:

Now, therefore, I, the Right Honourable Sir George Otto Trevelyan, Baronet, Her Majesty's Secretary for Scotland, do hereby confirm the Resolutions contained in the schedule appended to this Order.

#### SCHEDULE OF RESOLUTIONS.

First-

That under the authority, and subject to the provisions of the Local Authorities Loans (Scotland) Acts, 1891 and 1893, the Town Council do hereby, in exercise of their several statutory powers, create Stock, to be called the Inverness Corporation Redeemable Stock, and to be issued 

- A. For raising the following sums (amounting in the aggregate to the sum of Six Thousand Three Hundred and Seventy Pounds which has not been raised) (that is to say):—
  - (1) The sum of Two Thousand Eight Hundred and Seventy Pounds on account of the money which the Town Council have authority to raise by borrowing under the powers conferred on them by the Inverness Water and Gas Act, 1875, and Provisional Orders, dated 23rd May 1879 and 31st May 1892, for extension of the Gas Works.
  - (2) The sum of Five Hundred Pounds on account of the money which the Town Council have authority to raise by borrowing, in respect of the Common Good of the Burgh, under the Order of the Secretary for Scotland, dated 8th January 1894, conferring a borrowing power over the Common Good of £30,000 for adding to the Town Hall and Council Chamber.
  - (3) The sum of Three Thousand Pounds on account of the money which the Town Council, as such, and as coming in place of the Police Commissioners, have authority to raise by borrowing, under the powers conferred on them by the General Police and Improvement (Scotland) Act, 1862, the Burgh Police (Scotland) Act, 1892, the Roads and Bridges (Scotland) Act, 1878, the Inverness Water and Gas Act, Inverness Water and Gas Act, 1875, and Subsequent Provisional Orders, and the Local Authorities Loans (Scotland) Acts, 1891 and 1893, for meeting the expenses of and contingencies connected with creating and issuing the Stock now proposed.
- B. For raising instead of reborrowing the sum of Seventy-Three Thousand Nine Hundred and Twelve Pounds required by the Town Council for the purpose of paying off, when due, sums amounting to Seventy-Three Thousand Nine Hundred and Twelve Pounds, which will fall due on 15th May 1894, being a portion of the debts now subsisting on the security of outstanding securities granted by the Inverness Police Commissioners (whose powers and duties have been transferred to the Town Council by the Burgh Police [Scotland] Act, 1892) for the purposes of the Inverness Water and Gas Act, 1875 (that is to say):—

To the Public Works Loan Commissioners,  $\therefore \pounds 34,402 \circ \circ$ To various Debenture Holders for Water,  $\pounds 6,200 \circ \circ$ And for Gas,  $33,310 \circ \circ$  $39,510 \circ \circ$

and which sums the Town Council are, under said Act, authorised to reborrow.

- C. For raising the following sums (amounting in the aggregate to the sum of Fifty-Six Thousand Nine Hundred and Thirty-Two Pounds) which have been temporarily borrowed from the Caledonian Banking Company and others (that is to say) :--
  - (1) The sum of Seven Thousand Eight Hundred and Forty-Five Pounds on account of the sum which the Town Council, as coming in place of the Police Commissioners, have authority to raise by borrowing under the powers conferred upon them by the Inverness Water and Gas Act, 1875, and Provisional Orders, dated 23rd May 1879 and 31st May 1892, for extension of Water Works.
  - (2) The sum of Eleven Thousand Eight Hundred and Seventy Pounds on account of the money which the Town Council, as coming in place of the Police Commissioners, have authority to raise by borrowing under the powers conferred on them by the Inverness Water and Gas Act, 1875, and Provisional Orders, dated 23rd May 1879 and 31st May 1892, for extension of the Gas Works.
  - (3) The sum of Seven Thousand Five Hundred Pounds on account of the money which the Town Council, as coming in place of the Police Commissioners, have authority to raise by borrowing under the powers conferred on them by the Roads and Bridges (Scotland) Act, 1878, for cost of causewaying streets in the Burgh.
  - (4) The sum of Six Thousand Nine Hundred Pounds on account of the money which the Town Council, as coming in place of the Police Commissioners, have authority to raise by borrowing under the powers conferred on them by the General Police and Improvement (Scotland) Act, 1862, and the Burgh Police (Scotland) Act, 1892, and Acts explaining and amending the same, for construction of new main sewer in the Burgh (East Side of River).
  - (5) The sum of Twenty-Two Thousand Eight Hundred and Seventeen Pounds on account of the money which the Town Council have authority to raise by borrowing in respect of the Common Good of the Burgh under the Order of the Secretary for Scotland, dated 8th January 1894, conferring a borrowing power over the Common Good of Thirty Thousand Pounds.

Secondly-

That such Stock shall be issued at the price, and shall bear the dividends and be transferable in the manner hereinafter specified (that is to say):--

A. The minimum price of issue to be £100 per centum, or such other minimum price as the Town Council may from time to time fix, not less than 95 per cent.

- B. Tenders for the Stock to be made to the Town Chamberlain on or before 15th May 1894. A deposit of 10 per centum on the amount of Stock tendered for to be paid at the Head Office of the Caledonian Banking Company Limited, Inverness, or any of the Bank's branches or correspondents, at the time of the delivery of the tender. The balance due on account of the said tenders, when accepted, shall be payable on 25th May 1894.
- C. Dividends shall be at the rate of 3 per cent. per annum, payable half-yearly at Martinmas and Whitsunday. The first dividend shall be payable at Martinmas 1894, and shall be calculated for the half-year to that date on the full account of Stock.
- D. In the event of the receipt of tenders for a larger amount of Stock than that proposed to be issued at or above the minimum price, the tenders at the lowest price accepted shall be subject to proportionate diminution.
- E. Stock shall be issued in sums of Ten Pounds, or multiples of Ten Pounds.
- F. The Stock shall be transferred by deed.

Thirdly-

That such Stock shall be redeemable at par on 15th May 1914, in the option of the Town Council, or at any term of Whitsunday or Martinmas thereafter up to Whitsunday 1944, on a year's notice being given to the registered holders

of Stock, the Stocks to be paid off from time to time being determined by ballot. The Stock shall be redeemable in whole or in part, in the option of the Town Council; but the whole shall be redeemable on or before Whitsunday 1944.
