WHEREAS by an Act passed in the forty-fifth and forty-sixth years of Her Majesty's reign, intituled 'The Militia Act, 1882,' it is, amongst other things, enacted that, save as therein otherwise provided, the Militia shall be trained and exercised for not less than twenty-one days and not more than twenty-eight days in every year, at such times and at such places in every part of the United Kingdom as Her Majesty may appoint, and also that Her Majesty may, from time to time, with the advice of Her Privy Council, order that the period of training and exercise, in any
