the Edinburgh Gazette—and an Order may lawfully, in terms of the statute, be finally made and so published on or before the 12th day of March 1895, being the third Tuesday preceding the day of the first election of Parish Councillors—it shall be the duty of the County Council or of a committee thereof duly appointed for the purposes of the Local Government (Scotland) Act, 1894, as soon as may be after the date of this Order, to make provisionally any alteration or adjustment of Parish Wards within the County which would become necessary or expedient if such Order or Orders were finally made and published, and of the assessor to combine, divide, or adjust, in a copy of the list of persons qualified within the County to be Parish Electors, the portions of such list corresponding to each Parish affected, in such manner as to give provisional effect therein for registration and electoral purposes to the Proposed Order and to any such provisional alteration or adjustment of Parish Wards; and it shall be the duty of the Sheriff sitting at the Registration Court, or at any other Court or Courts to be held on or before the 28th day of February 1895, to revise and give provisional approval to the said list showing such combinations, divisions, or adjust-

4. If and when an Order is finally made and published on or before the 12th day of March 1895, but not otherwise, it shall be the duty of the County Clerk to furnish to the inspector of poor of each Parish affected by the Order a certified copy of so much of the said approved list as relates to such Parish as constituted by the Order, and in such case such copy or copies shall, in substitution for any other copy or copies, constitute the Parish Council Register for the Parish.
