N pursuance of the powers conferred upon me by the 'Wild Birds Protection Act, 1894,' and upon application by the County Council of the County of Kirkcudbright, I, the Right Honourable Sir George Otto Trevelyan, Baronet, Her Majesty's Secretary for Scotland, do hereby make the following Orders:—

1. The taking or destroying the eggs of the following species of Wild Birds is prohibited throughout the entire County of Kirkcudbright for a period of one year from the 1st day of June 1895, viz.:—

Buzzard (Buteo vulgaris). Goldfinch (Carduelis elegans). Great Crested Grebe (Podicipes cristatus). Common Gull (Larus canus) Blackheaded Gull (Larus ridibundus). Kestrel (Falco tinnunculus). Kingfisher (Alcedo ispida). Barn Owl (Strix flammea). Tawny Owl (Syrnium aluco). Long-eared Owl (Asio otus).
Short-eared Owl (Asio accipitrinus).

Alteration of Parish Areas.

PROPOSED ORDER No. XXVII.

PARISHES OF ARBROATH AND ST. VIGEANS.

Whereas it has been represented to me by the Town Council of Arbroath and the Parochial Boards of Arbroath and St. Vigeans that I should issue an Order, under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, uniting the Parish of Arbroath and the Parish of St. Vigeans into one Parish:

And whereas, after consulting with the Authorities concerned, and causing a local inquiry to be held, I am of opinion that it is expedient to give effect to the said representation:

Now, therefore, I, the Right Honourable Sir George Otto Trevelyan, Baronet, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order as follows:—

- r. The Parish of Arbroath and the Parish of St. Vigeans shall be united into one Parish, to be called the Parish of St. Vigeans.
- 2. The Parish Council of Arbroath and the Parish Council of the now existing Parish of St. Vigeans shall cease and determine, and their whole powers, rights, duties, property, liabilities, debts, officers, and servants shall be transferred to the Parish Council of the Parish constituted by this Order.
- 3. The Parish Councillors elected for the Parish of Arbroath and the Parish Councillors elected for the now existing Parish of St. Vigeans shall together form the Parish Council of the Parish constituted by this Order, and shall hold office until the date of the second election of Parish Councillors.
- 4. The said Parish Council shall meet on the fifteenth day of July 1895, and such meeting shall be deemed to be the first statutory meeting of the Parish Council.

5. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests.

This Order shall take effect on the fifteenth day of July 1895.

N.B.—These Regulations are liable to alteration for future Examinations.

I. The limits of age for this situation are 21 and 25. Candidates must be of the prescribed age on the first day of the Examination.

II. Candidates will be required to show what technical education and practical training they have undergone to qualify themselves for a situation of this nature, and they must satisfy the Civil Service Commissioners that they possess the special qualifications necessary for the situation. They must show that they have served the usual apprenticeship, for a period of at least five years to the printing trade or as 'compositor,' and must have been recently and for a sufficient time in actual employment Evidence on these points must be sent in at such times and in such manner as the Civil Service Commissioners may appoint. If such evidence should prove prima facie satisfactory, the Candidate will be admitted to examination, subject, in the case of his being successful in the competition, to such further inquiry, and the production of such further evidence, as may be necessary.

III. The Examination will be in the following subjects, viz.:—

- 1. Handwriting.
- 2. Orthography.
- 3. Arithmetic (to Vulgar and Decimal Fractions).
- 4. English Composition.
- 5. Knowledge of Printing.

(a) Executive.

(Candidates must have a thorough knowledge of good work, both as to the composition and presswork. They should be able readily to detect literal errors and defective execution of any sort, and to count the number of copies of each job with facility).

(b) Estimating, &c.

(Candidates must be able readily to measure up and price out work according to scale, to calculate the quantity of paper necessary for any job, and to cast up accounts with ease.)

IV. Candidates must pass to the satisfaction of the Civil Service Commissioners in all the abovementioned subjects.

V. A fee of £2 will be required from each Candidate attending the Examination.

VI. Application for permission to attend an Examination must be made at such times and in such manner as the Commissioners may appoint.
