self for re-examination as often as may be necessary to satisfy this condition."

II. This Ordinance shall come into force on and after the date on which it is approved by Her Majesty in Council.

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 1ST FEBRUARY 1897.)

COLINTON (MID-LOTHIAN) DISTRICT SWINE FEVER Order of 1897.

THE Board of Agriculture, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them ni this behalf, do order, and it is hereby ordered, as follows:-

Restriction on Movement of Swine out of or into Scheduled District.

1. Swine shall not be moved out of or into the District described in the Schedule to this Order, and hereinafter referred to as the Scheduled District, except as expressly authorised by this

Movement of Swine out of Scheduled District for Immediate Slaughter.

2.—(1) Swine (not being in a Swine Fever Infected Place and their movement not being prohibited by Notice of an Inspector of a Local Authority or of the Board given under any Order of the Board) may be moved out of the Scheduled District in a suitable vehicle to a slaughter-house situate in Mid-Lothian (county of Edinburgh), or in the burgh of Edinburgh, or in the burgh of Leith, or in the burgh of Musselburgh, for the purpose of immediate slaughter with a Movement Licence of the Local Authority of Mid-Lothian (county of Edinburgh), which Licence shall be in force for not more than two days, inclusive of the Order under section 39 of "The Factory and day of issue, and shall specify the name and
