By Her Majesty's Command,

The Ladies who propose to attend Her Majesty's Drawing Room are requested to bring with them to the Drawing Room two large cards, with their names clearly written thereon, one to be

left with The Queen's Page in Attendance, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

PRESENTATIONS.

The privilege of making Presentations to The Queen at a Drawing Room is restricted to those Ladies who have themselves been previously presented to Her Majesty, and who are themselves present at the Drawing Room.

Under such circumstances a Lady has the privilege of presenting one Lady only at a Drawing Room in addition to her Daughters or Daughters-in-law.

Daughters-in-law.

This restriction does not apply to Ladies who, from official position or other circumstances, are specially privileged to make Presentations to Her Majesty.

The Lady who proposes to present another must send in writing the name of such Lady to the Lord Chamberlain's Office, not later than two days previous to the Drawing Room, in order that the Lord Chamberlain may submit the name to Her Majesty, when, if it be approved, Presentation Cards will be forwarded.

Printed Forms for this purpose can be obtained at the Lord Chamberlain's Office.

It is particularly requested that the names of the Lady to be presented be very distinctly written on the Presentation Cards to be delivered to the Lord Chamberlain at the Drawing Room, in order that there may be no difficulty in announcing them to The Queen.

The number of Presentations is limited to 200.

It is not expected that Gentlemen will present themselves at the Drawing Room, except in attendance on the Ladies of their families.

Any Gentleman who under these circumstances should desire to be presented to The Queen will observe the same regulations as are in force for Her Majesty's Levees.

N pursuance of the powers conferred upon me by the "Wild Birds Protection Act, 1894," and upon application by the County Council of the County of Mid-Lothian, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby make the following Order:-

1. The taking or destroying the eggs of the following species of Wild Birds is prohibited throughout the entire County of Mid-Lothian during the currency of this Order, viz. :-

Dipper (Water Ousel, Water Crow) (Cinclus

aquaticus).

Jay (Garrulus glandarius). Raven (Corvus corax).

Bullfinch (Pyrrhula europæa).

Hawfinch (Coccothraustes vulgaris).

Goldfinch (Carduelis elegans).

2. The "Wild Birds Protection Act, 1880," shall apply within the County of Zetland during the currency of this Order to the following species of Wild Birds as if it had been included in the Schedule to the said Act, viz.:-

White-tailed or Sea-Eagle, or Erne (Haliaëtus albicilla).

3. This Order shall take effect on the first day of March 1897, and shall remain in force for one year from that day.
