THIS day the Right Rev. Dr. Mair, the Moderator, and a deputation of the General Assembly of the Church of Scotland, waited upon Her Majesty to present the following Address:—

The Right Honourable Lord Balfour of Burleigh, Secretary for Scotland, was in attendance.

To the QUEEN'S Most Excellent Majesty.

We, Your Majesty's loyal and dutiful subjects, the Ministers and Elders of the Church of Scotland, convened in General Assembly, beg most respectfully to offer to Your Majesty our cordial congratulations on the happy completion of Your Majesty's sixtieth year of Sovereignty.

The period during which Your Majesty has occupied the Throne has been remarkable for all that constituted the greatness and happiness of nations. Your Majesty's dominions have been vastly extended, and the hearts of many peoples are knit together as one in loyal recognition of Your Majesty's wise and righteous government, and in loving devotion to Your Majesty's Person.

All over Your Majesty's Empire the universal extension of the blessings of education, the discoveries of science, the inventions of art, the great development of commerce, the better understanding of the physical and moral laws under which the world is preserved, and, above all, the spreading of the gospel of the Lord's salvation, have resulted in an immense improvement in the material, social, and religious condition of all classes of Your Majesty's subjects.

We are profoundly conscious that, under God, who upholds and governs all things in heaven and earth, this prosperity in a large measure is to be attributed to Your Majesty's sincere devotion to the duties of a constitutional Sovereign, to the benignant influence of Your Majesty's good example in keeping His "Royal law and lively oracles," and to the intense interest which Your Majesty has always manifested in the welfare of Your people.

With fervent gratitude we recall many indubitable proofs of Your Majesty's attachment to the Church of Scotland, and also the innumerable acts of considerate kindness by which Your Majesty has enabled the people of Scotland to know their Queen in the intimacy which is the strongest bond which could unite them to Your Throne.

We received with dutiful respect the Order in Council exhorting that prayers and thanksgiving be offered up for Your Majesty on this occasion of holy rejoicing, and we have given instructions that this shall be done in all our churches and chapels on the 20th June, in perfect confidence that it will evoke the spontaneous feeling of the people in a united national thanksgiving.

We, who are convened in General Assembly, have already blessed Almighty God for the peace and prosperity enjoyed during Your Majesty's long and beneficent reign, and for the grace which, through sorrow and through joy, has sustained Your Majesty since the day when, in the name of the King of Kings, the crown was set upon Your head, and we earnestly pray that, protected by His power and rejoicing in His favour, Your Majesty may continue long in

health and peace, to be venerated and beloved in this world, and may finally in the world to come be crowned with glory and immortality.

I thank you for your loyal and dutiful Address, and for your warm congratulations on the completion of the sixtieth year of My reign.

I unite with you in gratitude to Almighty God, by whose good providence so many blessings have been bestowed upon My country; and I bespeak your prayers for a continuance of His mercies.

I gladly avail Myself of this opportunity to renew the assurance of My attachment to the Church of Scotland, of whose loyalty and devotion to My Throne and Person I have received so many proofs; and I pray that the blessing of God may attend your efforts to promote the advancement of true religion amongst the people committed to your charge.

# LOCAL AUTHORITIES LOANS (SCOT-LAND) ACTS, 1891 and 1893.

(54 and 55 Vict. c. 34, and 56 Vict. c. 8.)

Onder of the Secretary for Scotland confirming Resolutions of the Town Council of Coatbridge for the creation of Redeemable Stock.

WHEREAS by section 6 of the Local Authorities Loans (Scotland) Act, 1891 (hereinafter called the first recited Act), as amended by section 4, sub-section (2), of the Local Authorities Loans (Scotland) Act, 1891, Amendment Act, 1893 (hereinafter called the second recited Act), it is provided that a Resolution of a Local Authority, as in section 5 of the first recited Act, shall not take effect unless and until—

- (1) It is confirmed at a subsequent meeting of the Local Authority held after the Resolution has been published in the prescribed manner, and after the expiration of the prescribed time, being not earlier than fourteen days after the first publication of such Resolution; and
- (2) It is confirmed by the Secretary for Scotland, with or without modifications, by an Order under his hand and seal of office.

And whereas the Town Council of the Burgh of Coatbridge are the Local Authority in the said Burgh for the purposes of the first and second recited Acts.

And whereas Resolutions for the creation of redeemable stick under the said Acts were adopted by the Town Council of Coatbridge at a meeting held on the 12th day of August 1897, and were confirmed by the said Town Council at a subsequent meeting held after the Resolutions had been published in the prescribed manner, and after the expiration of the prescribed time, on the 31st day of August 1897.

And whereas these Resolutions have been submitted to me for confirmation, with or without modifications, in terms of the aforesaid Acts.

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby confirm the said Resolutions in the form in which they appear in the Schedule appended to this Order

#### SCHEDULE OF RESOLUTIONS.

RESOLVED FIRST,-

That, under the authority and subject to the provisions of the Local Authorities Loans (Scotland) Acts, 1891 and 1893, the Town Council do hereby, in exercise of their several statutory powers, create stock, to be called "The Coatbridge Corporation Redeemable Stock," and to be issued to an amount which shall be sufficient for the following purposes, but not exceeding fifty-four thousand three hundred pounds.

A.—For raising the sums of (1) £1593, 17s. 0d. (2) £680, 5s. 11d. (3) £1186, 2s. 6d. and (4) £517, 2s. 5d. to replace monies which the Town Council have borrowed under the powers conferred on them by the Coatbridge Burgh Act, 1885, the General Police (Scotland) Act, 1862, and Acts explaining and amending the same, for the sewers constructed in (1) the South-West, (2) Dunbeth, (3) Blairhill Drainage District, and (4) throughout the Burgh.

B.—For raising the sum of £7400 to replace monies which the Town Council have borrowed under the powers conferred on them by the said Coatbridge Burgh Act, 1885, the General Police (Scotland) Act, 1862, and the Roads and Bridges (Scotland) Act, 1878, for cost of causewaying streets within the said Burgh.

C.—For raising the sum of £22,207, 1s. 4d. to replace monies which the Town Council, as Police Commissioners, have borrowed under the powers conferred on them by the General Police (Scotland) Act, 1862, and the Burgh Police (Scotland) Act, 1892, for capital expenditure under these Acts.

D.—For raising the sum of £3691, 4s. 0d. to replace monies which the Town Council, as Police Commissioners, have borrowed under the powers conferred on them by the Burgh Police (Scotland) Act, 1892, for expenditure incurred in the erection of the Town Hall.

E.—For raising the sum of £2593, 6s. 2d. to replace monies which the Town Council, as Police Commissioners, have borrowed under the powers conferred on them by the General Police (Scotland) Act, 1862, for expenditure incurred in connection with the Slaughter-House.

F.—For raising such sums as may be necessary, but not exceeding in the aggregate the sum of £14,000, to defray certain contemplated expenditure in connection with the acquisition of a part share in Coathill Fever Hospital, the purchase and execution of certain drainage works, and other purposes, for all of which the Town Council have statutory powers to raise money by borrowing, the sums so required being only raised, however, after due compliance with any preliminary conditions in relation to the borrowing, which may be imposed by the Statute or Statutes conferring the borrowing powers, all as provided in section 51 of the Local Authorities Loans (Scotland) Act, 1891.

G.—For raising the sum of £431, 0s. 8d. to meet expenses incurred in connection with the creation and issue of stock which the Town Council are authorised to raise by borrowing under section 60 (1) of the Local Authorities Loans (Scotland) Act, 1891.

RESOLVED SECONDLY,-

That such stock shall be issued at the price and shall bear the dividends and be transferable in the manner hereinafter specified, that is to say—

A.—The minimum price of issue to be £100 per centum, the first dividend to be payable on the 15th day of May 1898.

B.—Tenders for the first issue of stock to be made to the Town Chamberlain not later than the 22nd day of October 1897, or, in respect of subsequent issues under these Resolutions, at such date or dates as the Town Council may fix. A deposit of 5 per centum on the amount of stock tendered for to be paid at the Clydesdale Bank Limited at the time of the delivery of the tender.

C.—The date for payment of the balance of the tenders for the first issue when accepted to be the 11th day of November 1897, or, in the case of subsequent issues, such later date as the Town Council may fix. In case of default in the payment of such balance at the proper date, the deposit will be liable to forfeiture.

D.—Dividends at  $2\frac{3}{4}$  per centum per annum, payable half-yearly.

E. — Dividends on the total amount of the stock issued (calculated from the 11th day of November 1897 as regards the first issue, and from such later date as the Town Council may fix in the case of subsequent issues), to be payable on the 15th day of May 1898, and on each 11th day of November and 15th day of May thereafter till the stock is redeemed.

F.—In the event of the receipt of tenders for a larger amount of stock than that proposed to be issued at or above the minimum price, the tenders at the lowest price accepted shall be subject to proportionate diminution.

G.—Stock to be issued in sums of not less than £50, or in multiples of that amount,

H.—Stock to be transferable by deed, and not in books.

# RESOLVED THIRDLY,-

That such stock shall be redeemable at par, in whole or in part, at the option of the Town Council, at 11th November 1907, or at any term of Whitsunday or Martinmas thereafter till 11th November 1937, on giving six months' previous notice, the particular holding or holdings of stock to be from time to time redeemed being determined by ballot. The whole stock to be redeemed at or before 11th November 1937.

#### RESOLVED FOURTHLY,-

That an agreement be entered into with the Commissioners of Inland Revenue for the payment to them of composition under the provisions of the Stamp Act, 1891, for the stamp duty on transfers of stock issued under the foregoing Resolutions.
