#### Alteration of Parish Areas.

#### ORDER No. XXXII.

#### PARISHES OF DUNKELD AND DOWALLY AND CAPUTH.

WHEREAS it has been represented to me by the Parish Council of the Parish of Dunkeld and Dowally that I should issue an Order, under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, making the boundaries of the Parish of Dunkeld and Dowally co-extensive with the School District of Dunkeld and Dowally; And whereas, after consulting with the Authorities concerned, and causing a local inquiry to be held, I am of opinion that it is expedient to give effect to the said representation;

And whereas I caused the proposed Order to be published in the Edinburgh Gazette of the 28th September 1897:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred on the Secretary for Scotland by the Local Government (Scotland) Acts, order as follows :—

1. The portion of the Parish of Caputh hereinafter defined, situated within the boundaries of the School District of Dunkeld and Dowally, shall cease to be part of the Parish of Caputh, and shall form part of the Parish of Dunkeld and Dowally; that is to say, the portion adjoining the Parish of Dunkeld and Dowally, and contained within a line starting from the point where the present boundary between Dunkell and Dowally and Caputh coming up from the south reaches the wall forming the north boundary of Letter Hill, thence following the said boundary wall northward to Catchpenny on the Dunkeld and Snaigow Road, and thence following the Athole Estate boundary along the line of the Old Clunie Road to the point at the south march of Laighwood where the Parishes of Caputh and Clunie meet, and thence following the present boundary between the said Parishes of Caputh and Clunie northward until that boundary meets the boundary of the Parish of Dunkeld and Dowally at Riemore.

2. The Parish Council of Dunkeld and Dowally shall assume responsibility for and shall relieve the Parish Council of Caputh of all advances which the latter body may be called upon to make for or on account of any pauper whose claim is derived (1) from birth within the said portion of the Parish of Caputh prior to the 15th day of May 1898, or (2) from residence for the statutory period in the said portion of the Parish of Caputh prior to the 15th day of May 1898.

3. The portion of the Parish of Capath by this Order annexed to the Parish of Dankeld and Dowally shall cease to be part of the County Council Electo al Division of Capath, and shall form part of the County Council Electoral Division of Dankeld.

4. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.

#### Alteration of Parish Areas.

#### ORDER No. XXXIII.

PARISHES OF STOW, SELKIRK, GALASHIELS, AND YARROW AND MEGGAT (NEW PARISH OF CADDONFOOT).

HEREAS it has been represented to the Secretary for Scotlan 1 by the School Board of the quoad sacra Parish of Caddonfoot, that he should issue an Order under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, constituting the quoad sacra Parish of Caddonfoot (with the exception of the portion thereof situated within the Parish of Innerleithen and County of Peebles), together with the portion of the Parish of Stow outside the boundaries of the said quoad sacra Parish of Caddonfoot, but situated within the C unty of Selkirk, into a separate Parish quoad civilia;

And whereas the Authorities concerned have been consulted and a local inquiry has been held;

And whereas I am of opinion that it is expedient to give effect to the said representation;

And whereas I caused the proposed Order to be published in the Edinburgh Gazette of the 28th September 1897:

Now, therefore, I. the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland. do. in virtue of the powers conferred upon the Secretary for S otland by the Local Government (Scotland) Acts, order as follows :--

1. The portion of the Parish of Stow situated within the County of Selkirk, and the portions of the Parishes of Selkirk, Galashiels, and Yarrow and Meggat situated within the boundaries of the *quoad sacra* Parish of Caddonfoot, shall cease to be parts of the said Parishes of Stow, Selkirk, Galashiels, and Yarrow and Meggat respectively, and shall form a separate Parish to be called the Parish of Caddonfoot.

2. The Parish Council of Caddonfoot shall assume responsibility for, and shall relieve the Parish Council of Stow, the Parish Council of Selkirk, the Parish Council of Galashiels, and the Parish Council of Yarrow and Meggat of all advances which the said Parish Councils respectively may be called upon to make for or on account of any pauper whose claim is derived from birth prior to the 6th day of December 1898, or from residence for the statu ory period prior to the 6th day of December 1898, in the said respective portions of the Parishes of Stow, Selkirk, Galashiels, and Yarrow and Meggat.

3. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.

4. For the purpose of receiving the Parish Council Register prior to the election of a Parish Council and summoning the first statutory meeting of the Parish Council of Caddonfoot, in terms of the Local Government (Scotland) Act, 1894, the In-pector of Poor of the now existing Parish of Stow shall be deemed to be the In-pector of Poor of the Parish constituted by this Order.

5. This Order shall take effect on the 15th day of May 1898, for all purposes connected with the election of Parish Councils, and on the 6th day of December 1898 for all other purposes.

PARISHES OF COLINTON AND CRAMOND AND CITY PARISH OF EDINBURGH.

WHEREAS it has been represented to me by the County Council of the County of Mid-Lothian that I should issue an Order, under section 51 of the Local Government (Scot.and) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, transferring from the City Parish of Edinburgh the two portions thereof lying outside the boundaries of the City and Royal Burgh of Edinburgh, as fixed by the Edinburgh Extension Act, 1896, and annexing the same to the adjoining Parishes of Colinton and Cramond respectively;

And whereas, after consulting with the Authorities concerned, I am of opinion that it is expedient to give effect to the said representation;

And whereas I caused the proposed Order to be published in the Edinburgh Gazette of the 28th September 1897:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred on the Secretary for Scotland by the Local Government (Scotland) Acts, order as follows :---

1. The portion of the City Parish of Edinburgh adjoining the Parish of Colinton, and not included within the boundaries of the City and Royal Burgh of Edinburgh, as fixed by the Edinburgh Extension Act, 1896, shall cease to be part of the City Parish of Edinburgh, and shall form part of the Parish of Colinton.

2. The portion of the City Parish of Edinburgh adjoining the Parish of Cramond and not included within the boundaries of the City and Royal Burgh of Edinburgh, as fixed by the Edinburgh Extension Act, 1896, shall cea e to be part of the City Parish of Edinburgh, and shall form part of the Parish of Cramond.

3. The Parish Council of Colinton and the Parish Council of Cramond shall respectively assume responsibility for, and shall respectively assume responsibility for, and shall resieve the Parish Council of the City Parish of Edinburgh of all advances which the latter body may be called upon to make for or on account of any pauper whose claim is derived (1) from birth prior to the 15th day of May 1898, or (2) from residence for the statutory period prior to the 15th day of May 1898, in the said respective portions of the City Parish of Edinburgh.

4. The portion of the City Parish of Edinburgh by this Order annexed to the Parish of Colinton, shall cease to be part of the County Council Electoral Division of Edinburgh Landward (South), and shall be added to, and form part of, the Electoral Division of Colinton South.

5. The portion of the City Parish of Edinburgh by this Order annexed to the Parish of Cramond shall cease to be part of the County Council Electoral Division of Edinburgh Landward (North), and shall be added to, and form part of, the Electoral Division of Cramond.

6. The Parish Councillors, at the date of this Order, holding office for the said respective portions of the City Parish of Edinburgh, shall continue to hold office until the 1st day of November 1898, being the date of the second election of Parish Councillors in the said Parish.

7. The School Board of the Burgh of Edinburgh shall pay to the School Board of the Parish of Coluton the sum of twenty Shillings yearly for each child enrolled during the school year last ended at Slateford Public School, or at Longston Public School, whose parents or guardians reside within the district of the School Board of the Burgh of Edinburgh.

8. Nothing herein contained shall affect the rights of creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.

This Order shall take effect on the 15th day of May 1898.
