The Civil Service Commissioners hereby give notice that the following Regulations are published with the consent of the Lords Commissioners of Her Majesty's Treasury, viz. :—

REGULATIONS respecting Open Competitive Examinations for situations as Female Learner in the Department of the Postmaster-General in Edinburgh, Dublin, and certain other Towns.

These Regulations are liable to alteration for future Examinations.

1. Candidates will be required to satisfy the Civil Service Commissioners—

- (a) That their age on the day of the Examination is not less than 15 nor more than 18.
- (b) That they are duly qualified in respect of health and character.
- (c) That they are unmarried or widows.

2. At each Examination the number of Candidates to be selected will be such as the Postmaster-General may from time to time fix.

3. The Examination will be in the following subjects, viz. :—

1. Handwriting.
2. Orthography.
3. English Composition, to be tested by a short essay or letter on a simple subject.
4. Arithmetic, including Vulgar and Decimal Fractions and Percentages.
5. Geography (general).

Candidates who fail to obtain such an aggregate number of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency will not be regarded as qualified.

4. Candidates must be at least 5 feet in height. No officer, however, will be retained in the Service who does not attain the height of 5 feet 2 inches before completing her nineteenth year.

5. No Candidate will be admitted to Examination who does not, at such time as may be fixed by the Civil Service Commissioners, produce an undertaking, signed by her parent or guardian, that she will, if successful, reside within a suitable distance from the Post Office, either with her parents or guardians, or with relations or friends approved by such parents or guardians.

6. Persons holding situations in the Civil Service will not be eligible unless they produce to the Civil Service Commissioners the written permission of the authorities of their Department to attend the Examination, dated before the commencement of the Competition.

7. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

8. A fee of 3s. will be required from every Candidate attending the Examination.

NOTE.—Female Learners will be required to resign their appointments on marriage.

Noup Head—Intended Light.

The Commissioners of Northern Lighthouses
 have given notice that, on and after 22nd
 November 1898, a white group flashing light,
 with a period of one minute, will be exhibited
 from a lighthouse recently erected on Noup Head,
 Orkney Islands.

Noup Head Light, with a candle power of
 51,000 candles, will show five flashes in quick
 succession, occupying about twenty seconds,
 followed by an eclipse of about forty seconds; it
 will be elevated about 260 feet above high water,
 and visible in clear weather from a distance of
 22 miles from the bearing of N. 5° W., through
 north and east, to about S. 82° W. From an
 observer within three quarters of a mile of the
 land on its west side the light will be obscured by
 cliffs; it will also be visible between the bearings
 of S. 80° W. and N. 56° W. when not obscured
 by the hills and cliffs of Westray and Papa
 Westray. The lighthouse is a white cylindrical
 tower, 79 feet high.

INNELLAN PIER.

(PROVISIONAL ORDER.)

(Extension of Existing Pier and other Works; Lateral and Vertical Deviations; Excavation and Dredging; Tolls, Rates, Duties, and Charges, and Alteration of Existing Tolls, Rates, Duties, and Charges; Borrowing of Money; Maintenance, Management, and Administration of Pier; and other purposes.)

NOTICE is hereby given that application is intended to be made to the Board of Trade, on or before the 23rd day of December next, by or on behalf of Mrs. Caroline Mary Hetley Pleydell Bouverie Campbell Wyndham, of Dunoon, wife of Philip Arthur Pleydell Bouverie Campbell Wyndham, late a Lieutenant-Colonel in Her Majesty's Indian Army (hereinafter, with her heirs, assignees, and successors, called and referred to as "the Promoter"), for a Provisional Order pursuant to "The General Pier and

Harbour Act, 1861," and "The General Pier and Harbour Act, 1861, Amendment Act," for all, or some of the following, among other powers and purposes; that is to say—

To authorise the Promoter to construct and maintain the following Works (that is to say):—

An extension (consisting of an open wooden Pier) of the existing Pier at Innellan, on the Firth of Clyde, commencing at a point on the face of the said existing Pier 31 yards or thereabouts, measuring in a northerly direction along the same from the extreme south-east corner, and thence extending in a south-easterly direction for a distance of 33 yards or thereabouts, and thence in a south-westerly direction for a distance of 27 yards or thereabouts, and there terminating in the bed of the Firth of Clyde.

Together with all necessary embankments, excavations, walls, approaches, roads, wharves, waiting-rooms, warehouses, sheds, cranes, mooring buoys, lights, water-pipes, and other works and conveniences in connection with the said existing Pier and the proposed extension thereof (all hereinafter included in the expression "the Pier.")

Which said existing Pier and proposed extension thereof and works and conveniences aforesaid are and will be situate within the Parish of Dunoon or united Parish of Dunoon and Kilmun, and County of Argyll, and on the foreshore and in the bed of the Firth of Clyde in or *ex adverso* of the said Parish or united Parish and County of Argyll.

To authorise the Promoter, in the construction of the said proposed Works, to deviate laterally within the limits of deviation shown on the Plans, and vertically from the levels shown on the sections, to be deposited as after mentioned to any extent which may be defined in the Order.

To empower the Promoter to excavate the shore and bed of the Firth of Clyde adjoining and near to the Pier, and to remove all shingle, rocks, either above or below high water mark, and shoals within such limits as may be defined in the Order, and to dredge, scour, deepen, and improve from time to time the approaches to the Pier, and to use and appropriate the materials so dredged.

To authorise the Promoter to levy tolls, rates, duties, and charges on steamboats, vessels, boats, and other craft using the Pier, and calling at or departing therefrom; and on passengers, goods, animals, fish, and things embarked or disembarked, shipped or unshipped, loaded or unloaded at the Pier, or in respect of the use of any waiting-room, warehouse, shed, crane, mooring buoy, work, or convenience connected therewith. To provide for the fixing, regulating, and collection of such tolls, rates, duties, and charges; to alter existing tolls, rates, duties, and charges; to confer, vary, alter, or extinguish exemptions from payment of tolls, rates, duties, and charges; and to confer, vary, or extinguish other rights, privileges, and agreements in connection therewith.

To authorise the Promoter to borrow money for the purposes of the Pier and Works, and of the Order, on the security of the Pier and the lands and property connected therewith, and of the tolls, rates, duties, and charges authorised to be levied by the Order, or of any or either of them, and to re-borrow from time to time, and to pro-

vide for the repayment and extinction of moneys borrowed.

To provide for the maintenance, management, and administration of the Pier and all matters relating thereto; to authorise the Promoter to let or lease the Pier and the tolls, rates, duties, and charges or any of them; to make, alter, and rescind bye-laws, rules, and regulations for the management, use, and protection of the Pier, and for the regulation and control of all vessels calling at or departing from the Pier, and for the regulation and control of all persons embarking and disembarking at the Pier; and of all traffic embarked or disembarked, loaded or unloaded, at or near the Pier; and to impose and recover penalties for the breach or non-observance of such bye-laws, rules, and regulations; and to appoint and remove Piermasters, and other officers and servants.

To define the limits within which the powers of such Piermasters, officers, and servants may be exercised.

To authorise the Promoter to carry the Order into effect; to confer on the Promoter all powers, rights, privileges, and authorities which may be necessary for that purpose, and to vary or extinguish all rights, privileges, and agreements which will or may interfere with the carrying out of the purposes of the Order.

To incorporate with the Order all or some of the provisions of the Lands Clauses Acts, the Railways Clauses Consolidation (Scotland) Act, 1845; the Harbours, Docks, and Piers Clauses Act, 1847; and the General Pier and Harbours Acts.

(Extension of the Municipal and Police Boundaries of the Burgh of Dumbarton; Disjunction of Added Districts from County of Dumbarton and Jurisdiction of County and other Local Authorities, and Transference of their Powers; Dissolution of Local and other Authorities in Added Districts; Extension to Added Districts

of Franchises, Rights, and Privileges of Existing Burgh; Alteration of Wards; Rates and Assessments; Extension of Limits of Gas and Water Supply; Guarantee Rate in respect of Interest on Moneys borrowed by Dumbarton Harbour Board; Application, Incorporation, Amendment or Repeal of Acts; and other purposes.)

NOTICE is hereby given that application is intended to be made to Parliament in the ensuing Session by the Provost, Magistrates, and Town Council of the Royal Burgh of Dumbarton (hereinafter called "the Town Council"), for leave to bring in a Bill (hereinafter called "the Bill") for the following or some of the following powers and purposes, that is to say:—
