(Power to Borrow Additional Moneys for the Purposes of the Enlargement, Alteration, Improvement, and Maintenance of the Harbour; Application of Aberdeen Harbour Act, 1895, to such Additional Borrowing; Incorporation and Amendment of Acts, and other purposes.)

NOTICE is hereby given that application is intended to be made to Parliament in the ensuing Session by the Aberdeen Harbour Commissioners (hereinafter called "the Commissioners") for an Act (in this notice called "the intended Act") to effect all or some of the following purposes:—

1.
