#### GLASGOW DISTRICT SUBWAY COMPANY.

Additional Capital; Application of Existing Funds; Definition and Regulation of Capital; Incorporation and Amendment of Acts and other Purposes.

NOTICE is hereby given, that application is intended to be made to Parliament in the next ensuing Session by the Glasgow District Subway Company (hereinafter called "the Company") for leave to bring in a Bill (hereinafter called "the Bill") for conferring on the Company the powers and effecting the objects and purposes following or some of them (that is to say):—

To authorise the Company to increase their Capital and to raise further moneys for the general purposes of their undertaking and of the Bill by the creation and issue of New Shares or Stock with or without a guaranteed or preferential or cumulative dividend or other rights and privileges attached thereto and by borrowing and by the creation and issue of Mortgages Debentures or Debenture Stock or by any of those means and that upon such terms and conditions and subject to such provisions with respect to the application of the moneys to be so raised as aforesaid and otherwise as may be prescribed by the Bill: and to apply their existing funds and any moneys they have power to raise to the purposes of the Bill: and if need be to alter declare define and regulate the Capital and borrowing powers of the Company and to make such other provisions in regard thereto as the Bill may prescribe.

To vary or extinguish all existing rights and privileges which would in any way interfere with the objects of the Bill or any of them and to confer other rights and privileges.

To incorporate with the Bill (with or without amendment) or make applicable thereto all or some of the provisions of the Companies Clauses Consolidation (Scotland) Act 1845; the Companies Clauses Act 1863; and the Companies Clauses Act 1869.

To alter amend enlarge extend or repeal so far as may be necessary for the purposes of the Bill all or some of the provisions of the Glasgow District Subway Act 1890 and the Glasgow District Subway (Further Powers) Act 1894, or either of those Acts and any other Act or Acts

relating to the Company or their undertaking. Printed copies of the Bill will be deposited in the Private Bill Office of the House of Commons, on or before the 21st day of December next.

#### DUMFRIES ELECTRIC SUPPLY.

(The Production, Storage, and Supply of Electricity by the Provost, Magistrates, and Town Council of the Royal Burgh of Dumfries within that Burgh; the Acquisition and Appropriation of Lands and Construction of Works; the Breaking-up and Interference with Streets, the Laying-down and Erection of Electric Lines, Pipes, and Apparatus; the Taking and Recovery of Rates and Charges; the Entry into Houses and Lands; the Making of Contracts, and the Transfer of the Undertaking; the Borrowing of Money; and other Matters.)

NOTICE is hereby given that the Provost, Magistrates, and Town Council of the Royal Burgh of Dumfries (who are hereinafter called the Council, and whose address is Town Hall Buildings, Dumfries) intend to apply to the Board of Trade, on or before the 21st day of December next, for a Provisional Order (hereinafter called the Order), under the Electric Lighting Acts, 1882 and 1888, and the Electric Lighting (Scotland) Act, 1890, for all or some of the following amongst other purposes (that is to say):

1. To authorise the Council to produce, store, supply, and distribute electricity for public and private purposes as defined by the said Acts, within the Royal Burgh of Dumfries in the county of Dumfries (hereinafter called the area of supply).

2. To enable the Council to purchase, take on lease, and hold lands or interests or easements in or over lands, or to appropriate, for the purposes of the Order, any lands belonging to or held by them, and to erect, maintain, work and use upon such lands all necessary or proper engines, dynamos, batteries, machinery, apparatus, works, buildings, and appliances for generating, producing, storing, supplying, and distributing electricity, or for other purposes of the undertaking, and to empower the Council to sell or dispose of any lands not required for purposes of the undertaking.

3. To authorise the Council to open, break up, and interfere with all streets, roads, public places, ways, footpaths, railways, canals, navigable rivers, towing paths, bridges, culverts, sewers, drains, gas and water mains and pipes, and telegraph and telephone and other wires within the area of supply; and to lay down, erect, maintain, renew, and remove, either above or under ground of
