## SCOTTISH OFFICE, WHITEHALL, December 9, 1898.

THE Secretary for Scotland hereby gives notice that the following Order has been made by him under the Wild Birds Protection Acts, 1880 to 1896, upon the application of the County Council of Dunbarton:—

SCOTLAND—SOUTHERN DISTRICT.

The Wild Birds Protection (County of Dunbarton) Order, 1898.

Whereas by the Wild Birds Protection Acts, 1880 to 1896, as applying to Scotland, it is, amongst other things, provided as follows:—

Firstly.—Any person who between the first day of March and the first day of August in any year shall knowingly and wilfully shoot or attempt to shoot, or shall use any boat for the purpose of shooting or causing to be shot, any Wild Bird, or shall use any lime, trap, snare, net, or other instrument for the purpose of taking any Wild Bird, or shall expose or offer for sale, or shall have in his control or possession after the fifteenth day of March, any Wild Bird recently killed or taken, shall, on conviction of any such offence before the Sheriff, in the case of any Wild Bird which is included in the Schedule hereunto annexed, forfeit and pay for every such bird in respect of which an offence has been committed a sum not exceeding one pound, and, in the case of any other Wild Bird, shall for a first offence be reprimended and discharged on payment

Note.—By an Order of the Secretary for Scotland, dated 27th July 1891, the close time enacted by this section has been extended, so far as regards the County of Zetland, to the 31st day of August in each year.

of costs, and for every subsequent offence forfeit and pay for every such Wild Bird in respect of which an offence is committed a sum of money not exceeding five shillings, in addition to the costs. This section shall not apply to the owner or occupier of any land, or to any person authorised by the owner or occupier of any land, killing or taking any Wild Bird on such land not included in the Schedule hereto annexed.

Secondly.—The Secretary for Scotland may, upon application by the County Council of any administrative county by Order prohibit—

 The taking or destroying of Wild Birds' eggs in any year or years in any place or places within that county; or

(2) The taking or destroying the eggs of any specified kind of Wild Birds within that county or part or parts thereof, as recommended by the said County Council, and set forth in the said Order.

Thirdly.—The Secretary for Scotland may, on the representation of the Council of any administrative county, order that the principal Act shall apply within that county, or any part or parts thereof, to any species of Wild Bird not included in the Schedule of that Act, as if that species of Wild Bird were included in the Schedule of that Act.

Fourthly.—The powers exerciseable by the Secretary for Scotland shall extend to the making of an Order prohibiting, for special reasons mentioned in the application, the taking or killing of particular kinds of Wild Birds during the whole or any part of that period of the year to which the protection of Wild Birds under the Act of 1880 does not extend, or the taking or killing of all Wild Birds in particular places during the whole or any part of that period.

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, in pursuance of the powers conferred upon me by the said Acts, and upon application by the County Council of the County of Dunbarton, do hereby make the following Order:—

## I.—Birds.

1. The "Wild Birds Protection Act, 1880," shall apply within the County of Dunbarton during the currency of this Order to the following species of Wild Birds as if they had been included in the Schedule to the said Act, viz.:—

Bullfinch (Pyrrhula europæa).
Buzzard (Buteo vulgaris).
Crossbill (Loxia curvirostra).
Dipper (Cinclus aquaticus).
Hawfinch (Coccothraustes vulgaris).
Jay (Garrulus glandarius).
Kestrel (Falco tinnunculus).
Merlin (Falco æsalon).
Osprey (Pandion haliaëtus).
Peregrine Falcon (Falco peregrinus).

Quail (Coturnix communis). Raven (Corvus corax). Siskin (Chrysomitris spinus). Tufted Duck (Fuligula cristata).

2. The taking or killing of any of the following kinds of Wild Birds is prohibited, so far as concerns the said County, throughout the whole year during the currency of this Order:—

Buzzard (Buteo vulgaris).
Chough (Pyrrhocorax graculus).
Dotterel (Eudromias morinellus).
Goldfinch (Carduelis elegans).
Great-crested grebe (Podicipes cristatus).
Kestrel (Falco tinnunculus).
Kingfisher (Alcedo ispida).
Osprey (Pandion haliaëtus).
Owl, Barn (Strix flammea).
Owl, Long-eared (Asio otus).
Owl, Short-eared (Asio accipitrinus).
Owl, Tawny (Syrnium aluco).
Peregrine Falcon (Falco peregrinus).
Woodpecker, Great Spotted (Dendrocopus major).

#### II.—Eggs.

3. The taking or destroying the eggs of the following species of Wild Birds is prohibited within the said County during the currency of this Order, viz.:—

Bullfinch (Pyrrhula europæa). Buzzard (Buteo vulgaris). Chough (Pyrrhocorax graculus). Crossbill (Loxia curvirostra). Dipper (Cinclus aquaticus). Dotterel (Eudromias morinellus). 4. The taking or destroying the eggs of the Lapwing (Vanellus cristatus) is prohibited within the said County after the fifteenth day of April in each year during the currency of this Order.

#### III.—Currency of Order

5. This Order shall take effect on the first day of January 1899, and shall remain in force for three years from that day.

#### IV.—Title.

6. This Order may be cited as "The Wild Birds Protection (County of Dunbarton) Order, 1898."

#### V.—Repeal.

7. The Order of 27th November 1897 is hereby repealed.

#### SCOTTISH OFFICE, WHITEHALL, December 10, 1898.

NOTICE is hereby given that the Secretary for Scotland has confirmed the following Bye-law passed by the Fishery Board for Scotland,

BYE-LAW (No. 17) made by the Fishery Board for Scotland, under the powers conferred on the Board by the Sea Fisheries (Scotland) Amendment Act, 1885.

I. Bye-law (No. 12) made by the Fishery Board for Scotland on the 30th day of October, and confirmed by the Secretary for Scotland on the 29th day of December 1893, is hereby revoked.

II. This Bye-law shall apply to the whole of the sea adjoining Scotland, and within the exclusive fishery limits of the British Islands, provided that its application shall not extend to the Solway Firth nor the Pentland Firth, nor to (1) beam trawling (under conditions duly authorised from time to time) in the waters inside of three straight lines drawn (a) from Garroch Head, Island of Bute, to Gull Point, Little Cumbrae, (b) from Gull Point to Portincross Castle, on the Ayrshire coast, and (c) from Colintraive Hotel, Argylishire, to a point due south (magnetic) on the Island of Bute; nor (2) beam trawling for shrimps (under conditions duly authorised from time to time) in the waters inside of a straight line drawn from Eggerness Point, on the Wigtownshire coast, to Ringdoo Point, at the west side of Fleet Bay, on the Kirkcudbrightshire coast.

III. From and after the date when this Byelaw shall come into force it shall not be lawful within the said limits for any person, unless on the service or possessing the written authority of the Fishery Board for Scotland, under the hand of the Secretary thereof, to use, by trailing or the North-Western Provinces of India.

dragging along the bottom of the sea, any net (including a seine or circle net) or other instrument for the capture of sea fish other than herrings, sprats, sparlings, and shell fish.

IV. Nothing in this Bye-law shall affect the validity of Bye-law (No. 13) made by the Fishery Board for Scotland on the 8th day of March, and confirmed by the Secretary for Scotland on the 19th day of April 1895.

V. This Bye-law shall come into force from and after the date of its confirmation by the Secretary for Scotland.
