<sup>\*</sup> Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

REGULATIONS respecting Open Competitive Examinations for situations as Female Learner in London in the Department of the Posmaster-General.

These Regulations are liable to alteration for future Examinations.

- 1. Candidates will be required to satisfy the Civil Service Commissioners—
  - (a) That their age on the day of the Examination is not less than 15 nor more than 18.

NOTE. — In reckoning age for Competition, persons who have served for two consecutive years in any Civil situation to which they were admitted with the certificate of the Civil Service Commissioners may deduct from their actual age any time, not exceeding five years, which they may have spent in such service.

(b) That they are unmarried or widows.

- (c) That they are duly qualified in respect of health and character.
- 2. At each Examination the number of Candidates to be selected will be such as the Postmaster-General may from time to time fix.
- 3. The Examination will be in the following subjects, viz:—
  - 1. Handwriting.
  - 2. Orthography.
  - 3. English Composition, to be tested by a short essay or letter on a simple subject.
  - 4. Arithmetic, including Vulgar and Decimal Fractions and Percentages.
  - 5. Geography (General).

Candidates who fail to obtain such an aggregate number of marks as may indicate, in the judgment of the Civil Service Commissioners, a competent amount of general proficiency will not be regarded as qualified.

- 4. Candidates must be at least 5 feet in height.
- 5. Persons who may have accepted a situation as Learner in any London office will not be eligible to compete. Other persons holding situations in the Civil Service will not be eligible unless they produce to the Civil Service Commissioners the written permission of the authorities of their Department to attend the Examination, dated before the commencement of the Competition.
- 6. No Candidate will be admitted to Examination who does not, at such time as may be fixed by the Civil Service Commissioners, produce an undertaking, signed by her parent or guardian, that she will, if successful, reside either with her parents or guardians, or with relations or friends approved by such parents or guardians.
- 7. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.
- 8. A fee of three shillings will be required from every Candidate attending the Examination.

NOTE.—Female Learners will be required to resign their appointments on marriage.

The Civil Service Commissioners further give notice that an Open Competitive Examination for not fewer than 85 situations as Female Learner in London will be held in London,

under the foregoing Regulations, on the 24th May 1899.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 4th May, an application, on the prescribed form, which may be obtained from the Secretary at once.

- 6. Persons holding situations in the Civil Service will not be eligible unless they produce to the Civil Service Commissioners the written permission of the authorities of their Department to attend the Examination, dated before the commencement of the Competition.
- 7. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.

8. A fee of 3s. will be required from every Candidate attending the Examination.
