# TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday the 24th instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vict. cap. 2, and 52 Vict. cap. 6, to the amount of £2,588,000, in replacement of Bills paid off on the 15th instant (£1,000,000), and of Bills falling due on the 30th instant (£1,588,000).

- 2. The Bills will be in amounts of £1000, £5000, or £10,000. They will be dated the 30th August 1900, and will be payable at three months, or six months, or nine months, or twelve months, after date (at the option of the persons tendering), viz., on the 30th November 1900, or 28th February 1901, or 30th May 1901, or 30th August 1901 respectively.
