\* Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

#### COLONIAL STOCK ACT, 1900. (63 and 64 Vict. c. 62.)

#### ORDER UNDER SECTION 2.

OTICE is hereby given, in pursuance of the Rules Publication Act, 1893, that the Treasury have made the following Order, under section 2 of the Colonial Stock Act, 1900:—

#### Order.

The Lords Commissioners of Her Majesty's Treasury, in virtue of the power bestowed upon them by section 2 of the Colonial Stock Act, 1900 (63 and 64 Vict. c. 62), are pleased to prescribe the following conditions under that section :---

#### Conditions.

1. The Colony shall provide by legislation for the payment out of the revenues of the Colony of any sums which may become payable to stockholders under any judgment, decree, rule, or order of a Court in the United Kingdom. 2. The Colony shall satisfy the Treasury that adequate funds (as and when required) will be made available in the United Kingdom to meet any such judgment, decree, rule, or order.

3. The Colonial Government shall place on record a formal expression of their opinion that any Colonial legislation which appears to the Imperial Government to alter any of the provisions affecting the stock to the injury of the stockholder, or to involve a departure from the original contract in regard to the stock, would properly be disallowed.
